A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AUTHORIZING THE CITY MANAGER TO EXECUTE A WORK ORDER WITH MARLIN PROVIDE ENGINEERING, INC. TO **PROFESSIONAL** ENGINEERING SERVICES FOR AN UPDATE TO THE CITY OF DORAL'S FIVE-YEAR PAVEMENT EVALUATION 2022 AND FIVE-YEAR MAINTENANCE AND REHABILITATION PLAN IN AN AMOUNT NOT TO EXCEED \$68,339.00; AND AUTHORIZING A BUDGET TRANSFER OF \$69,000.00 FROM ACCOUNT No. 101.80005.500341 TO ACCOUNT No. 101.80005.500310 TO PROVIDE SUFFICIENT FUNDING FOR THIS EFFORT; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the Public Works Department (PWD) has been implementing a fiveyear capital improvement program (CIP) developed for the pavement maintenance and rehabilitation of local roads under the jurisdiction of the City of Doral; and

WHEREAS, the five-year CIP for the pavement evaluation and 5-year maintenance and rehabilitation plan was completed in 2021 and requires to be updated by completing an evaluation of the pavement present condition on the City operated local roads; and

WHEREAS, with the completion of this program update, the PWD will be able to confirm and extend the service life of the pavement, re-prioritize scheduled maintenance, and maximize use of available funds; and

WHEREAS, the PWD requested a proposal from Marlin Engineering, Inc. for the provision of an update to the City of Doral's Five Year Pavement Management and Rehabilitation Plan which includes a quantitative and qualitative evaluation of all roadway pavement under the jurisdiction of the City of Doral, the development of a five year CIP that prioritizes the rehabilitation of roadway segments based on pavement

condition, and other miscellaneous tasks; and

WHEREAS, Marlin Engineering provide a proposal dated April 13, 2022, on a time and material basis in a not to exceed amount of \$68,339.00; and

WHEREAS, staff respectfully requests authorization for the City Manager to execute Work Order No. 7 for Marlin Engineering, Inc. to provide professional engineering services for the provision of an update to the City of Doral's Five-Year Pavement Management Program in an amount not to exceed \$68,339.00, a copy of which is attached as Exhibit "A"; and

WHEREAS, staff respectfully requests authorization for the City Manager to transfer \$69,000.00 available in the Transportation Fund Account No. 101.80005.500341 to Account No. 101.80005.500310 to provide sufficient funding for these services.

NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL
OF THE CITY OF DORAL AS FOLLOWS:

<u>Section 1.</u> Recitals. The above recitals are true and correct and incorporated herein.

Section 2. Approval. The work order between the City and Marlin Engineering, Inc. for the provision of an update to the City of Doral's Five-Year Pavement Management Program in an amount not to exceed \$68,339.00 as to form and legality by the City Attorney, and the transfer of \$69,000.00 available in the Transportation Fund Account No. 101.80005.500341 to Account No. 101.80005.500310 to provide sufficient funding for these services is hereby approved.

The City of Doral authorizes the firm of Marlin Engineering Inc. to provide professional engineering services for the provision of an update to the City of Doral's Five-Year Pavement Management Program. Where Marlin Engineering Inc. is a prequalified provider of professional engineering services selected in accordance with Consultant Competitive Negotiation Act (CCNA) requirements and approved by the City Council in October 2020 through Resolution 20-243. The work should be performed in accordance with the contract provisions contained in the Continuing Professional Services Agreement between Marlin Engineering Inc. and the City of Doral dated January 1, 2020, and the attached Proposal of April 13, 2022; submitted by your firm for the above referenced project.

SCOPE OF SERVICES AND SCEHDULE:

The scope of the project will be as described in the attached proposal from Marlin Engineering Inc. dated April 13, 2022, for the update of the Doral Pavement Evaluation 2022 (Five-Year Maintenance & Rehabilitation Plan). The schedule requires the scope of work to be completed within 150 Days of Notice to Proceed. All limitations of time set forth in this Work Order are of the essence. The performance of services associated with this Work Order will be executed on a time and material basis not to exceed the amount of \$68,339.00.

You are required by the Continuing Service Agreement to begin work subsequent to the execution of this Work Order, or as directed otherwise. If you fail to begin work subsequent to the execution of this Work Order, the City of Doral will be entitled to disqualify the Proposal and revoke the award.

Work Order incorporates the terms and conditions set forth in the Continuing Services Agreement dated January 1, 2020, between the parties as though fully set forth herein. In the event that any terms or conditions of this Work Order conflict with the Continuing Services Agreement, the provisions of this specific Work Order shall prevail and apply. Work Order is not binding until the City of Doral agrees and approves this Work Order.
