

**RESOLUTION No. 16-144**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, ESTABLISHING THE PROPOSED MILLAGE RATE FOR FISCAL YEAR 2016-2017, THE CURRENT YEAR ROLLED-BACK RATE AND THE DATE, TIME AND PLACE OF THE FIRST AND SECOND PUBLIC BUDGET HEARINGS AS REQUIRED BY LAW; DIRECTING THE CITY CLERK AND CITY MANAGER TO FILE SAID RESOLUTION WITH THE PROPERTY APPRAISER OF MIAMI-DADE COUNTY PURSUANT TO THE REQUIREMENTS OF FLORIDA STATUTES AND THE RULES AND REGULATIONS OF THE DEPARTMENT OF REVENUE AND THE STATE OF FLORIDA; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, on July 1, 2016, the Honorable Pedro J. Garcia, Miami-Dade County Property Appraiser, served upon the City of Doral a "Certification of Taxable Value" certifying to the City of Doral its 2016 taxable value; and

**WHEREAS**, the City Council has reviewed the taxable value supplied by the Property Appraiser; and

**WHEREAS**, the provisions of Florida Statutes Section 200.065 require that within thirty-five (35) days of service of the Certification of Taxable Value upon a municipality, said municipality shall be required to furnish to the Property Appraiser of Miami-Dade County the proposed millage rate, the current year roll back rate, and the date, time and place at which a public hearing will be held to consider the tentative millage rate and tentative budget and final millage rate and final budget; and

**WHEREAS**, the City Council desires to announce the dates of the first and second hearings to the Property Appraiser of Miami-Dade County; and

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:**

**Section 1. Recitals.** The foregoing recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

**Section 2. Proposed Millage Rate.** The proposed millage for the first public hearing is hereby declared to be 1.9000 mills, which is \$1.9000 per \$1,000.00 of assessed property within the City of Doral. The proposed millage is 7.53% greater than the rolled-back rate.

**Section 3. Rolled-Back Rate.** The current year rolled-back rate computed pursuant to Section 200.065, Florida Statute, is 1.7669 mills which is \$1.7669 per \$1,000.00 of assessed property within the City.

**Section 4. Budget Hearing Dates.** The dates, times and place of the first and second public hearings are hereby set as follows:

**Section 5. Transmittal.** The City Clerk and City Manager are directed to attach the original Certification of Taxable Value to a certified copy of this Resolution and serve the same upon the Honorable Pedro J. Garcia, Miami-Dade County Property Appraiser, on or before August 01, 2016.

**Section 6. Effective Date.** This Resolution shall be effective immediately upon adoption.
