

**RESOLUTION No. 19-289**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AUTHORIZING THE ADOPTION OF HOME DEPOT U.S.A. CONTRACT VIA THE OMNIA PARTNERS MARICOPA COUNTY (AZ) SOLICITATION, FOR THE PURCHASE OF MAINTENANCE AND HARDWARE SUPPLIES FOR THE CITY OF DORAL DEPARTMENTS, AS NEEDED; AUTHORIZING THE CITY MANAGER TO EXPEND BUDGETED FUNDS IN FURTHERANCE HEREOF; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, the City of Doral (the “City”) seeks to adopt the OMNIA Partners (formerly US Communities) Home Depot Contract, as a result of RFP# 16154, for the Purchase of Maintenance and Hardware Supplies, for the City of Doral Departments, as needed, in an amount not to exceed budgeted funds; and

**WHEREAS**, section 2-322 of the City Code of Ordinances provides that the City may enter into contracts competitively entered into by other governmental entities; and

**WHEREAS**, staff respectfully requests that the City Council authorize the City Manager to adopt the OMNIA Partners Maricopa County (AZ) Contract, which was competitively entered into in a manner like that set forth in Chapter 2, Article V, of the City’s Code of Ordinance, for the purchase of products and services, for the City of Doral Departments, as needed, and authorize the City Manager to expend budgeted funds in an amount not to exceed budgeted funds, for the period set forth in the OMNIA Partners Maricopa County (AZ) Contract and any approved additional subsequent extension; and

**WHEREAS**, staff respectfully requests that the City Council retroactively approves purchases as to comply with the procurement policy; and

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:**

**Section 1. Recitals.** The foregoing recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

**Section 2. Authorization.** The City Council hereby authorizes the City Manager to adopt the OMNIA Partners Maricopa County (AZ) Contract for the purchase of Maintenance and Hardware Supplies, for the City of Doral Departments, as needed, in amount not to exceed budgeted funds.

**Section 3. Implementation.** The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the provisions of this Resolution.

**Section 4. Effective Date.** This Resolution shall become effective immediately upon adoption.
