a) Environmental Task Force. – Dulce: Representatives from waste management and energy facility met to review increase of complains. Last 3 years historic complains increased by the end of the year (end of summer & fall). Landfill is planning to upgrade odor programs, person was hired to manage odor complains. Fernando indicated that the Landfill has the option to reduce odors more than they use to do. Odors have Increased from 3 to 7 am, Task Force requested Miami Dade Water & Sewer to analyze water and look for pollutants. Dulce presented full report and will present update.

- c) Noise Ordinance Horn should be used for emergencies only. Visit from Edgard Estrada, in charge of Code Enforcement from the City of Doral to explain what the city was doing to enforce codes, including noise codes. Explained that get evidence in the act is difficult, and that the best way to improve the situation is by education and preventive actions. Dulce to follow up for updates of initiatives to control horn noise next meeting.
