

**RESOLUTION NO. 11 – 147**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA AUTHORIZING THE CITY MANAGER TO RENEW THE INTERLOCAL AGREEMENT WITH THE CITY OF MIAMI SPRINGS FOR THE USE OF THE MIAMI SPRINGS MUNICIPAL POOL BY CITY OF DORAL RESIDENTS; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, in March of 2009, the City of Doral entered into an Interlocal Agreement with the City of Miami Springs permitting use of their municipal pool to Doral citizens and groups as Doral does not have its own municipal pool; and

**WHEREAS**, the Interlocal Agreement provides the community with the opportunity to enjoy aquatic recreation that includes swimming lessons and aqua aerobics; and

**WHEREAS**, both cities are desirous to renew this Interlocal Agreement once it expires in February 2012; and

**WHEREAS**, Staff respectfully requests that the City Council authorize the City Manager to renew the Interlocal Agreement with the City of Miami Springs for the use of the Miami Springs Municipal Pool by City of Doral residents.

**NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:**

**Section 1.** The City Council hereby authorizes the City Manager to renew the Interlocal Agreement with the City of Miami Springs for the use of the Miami Springs Municipal Pool by City of Doral residents.

**Section 2.** This Resolution shall become effective immediately upon its adoption.


