## **RESOLUTION No. 16-10**

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING AN ADDENDUM TO THE PREVIOUSLY APPROVED LEASE AGREEMENT WITH PETERSON'S HARLEY-DAVIDSON OF MIAMI. LLC. MODIFYING THE TERMS FOR THE LEASE OF TWO ADDITIONAL FLHP MOTORCYCLES FOR THE POLICE DEPARTMENT FLEET AT A COST OF \$9,000.00, AND INCREASING THE TOTAL NOT TO EXCEED CONTRACT AMOUNT TO \$129,000.00; AUTHORIZING THE CITY MANAGER TO EXECUTE THE LEASE ADDENDUM AND EXPEND BUDGETED FUNDS IN FURTHERANCE HEREOF; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral (the "City") has an existing lease agreement with Peterson's Harley-Davidson of Miami, LLC for the provision of 10 motorcycles for the Police Department, which will expire on November 2016 (the "Lease Agreement"); and

WHEREAS, the City has a need to purchase two additional FLHP motorcycles to

expand the Police fleet; and

WHEREAS, Peterson's Harley-Davidson of Miami, LLC has quoted the City a cost of \$9,000.00 to have the lease the desired motorcycles under the terms of the Lease Agreement; and

WHEREAS, to accomplish the purchase of the desired motorcycles, an addendum (the "Addendum") to the Lease Agreement must be approved

WHEREAS, staff has recommended that the City Council approve the Addendum for the lease of the two motorcycles, increasing the not to exceed contract amount for the Lease Agreement by \$9,000.00 to \$129,000.00, and authorize the manager to execute the addendum and expend budgeted funds in furtherance hereof.

## NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

<u>Section 1.</u> <u>Recitals.</u> The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

<u>Section 2.</u> <u>Approval</u>. The Addendum to Lease Agreement, attached hereto as Exhibit "A", which is incorporated herein and made a part hereof by this reference, approving the lease of two additional motorcycles for the police department at a cost of \$9,000.00 and increasing the not to exceed total contract amount to \$129,000.00, is hereby approved.

<u>Section 3.</u> <u>Authorization.</u> The City Manager is authorized to executed the Addendum and to expend budgeted funds in furtherance hereof. Funding for this request is available in account 001.60005.500440.

<u>Section 4.</u> <u>Implementation.</u> The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and provisions of this Resolution.

<u>Section 5.</u> <u>Effective Date.</u> This Resolution shall become effective immediately upon its adoption.

## Lease Addendum

Lease Addendum, made this 21<sup>st</sup> day of November, 2015 to Lease Agreement ("original Lease Agreement") dated November 6, 2014 between Peterson's Harley-Davidson of Miami, LLC (Lessor) and City of Doral (Lessee), states:
