## **RESOLUTION No. 22-217**

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, PURSUANT TO SECTION 2-322 OF THE CITY'S CODE OF ORDINANCES, APPROVING THE PURCHASE OF ONE (1) NEW POLICE VEHICLE VIA THE AGREEMENT BETWEEN THE FLORIDA SHERIFF'S ASSOCIATION CONTRACT No. FSA22-VEL30.0 AND GARBER FORD IN AN AMOUNT NOT TO EXCEED BUDGETED FUNDS; AUTHORIZING THE CITY MANAGER TO PURCHASE THE VEHICLE FROM THE NEXT LOWEST AND MOST RESPONSIVE BIDDER SUCCESSIVELY IF THE VENDOR IS NOT RESPONSIVE, OR A PURCHASE AGREEMENT CAN NOT BE NEGOTIATED WITH THE TOP BIDDER; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the Public Works Department (PWD) respectfully requests authorization from the Mayor and the City Council-Members to authorize the City Manager to purchase one (1) Ford Police Interceptor Utility vehicles from Garber Ford Inc. via the Florida Sheriffs Association Contract FSA 22-VEL30.0; and

WHEREAS, the new police vehicle is to replace one total loss Police vehicle (Units:256); and

WHEREAS, the PWD recommends that the City Council authorizes the City Manager to purchase one (1) Ford Police Interceptor Utility via the Florida Sheriffs Contract FSA 22-VEL30.0, which was competitively entered into in a matter similar to that set forth in Chapter 2, Article V of the City Code; and

WHEREAS, the City Manager's Office respectfully requests authorization to purchase the vehicle from the next lowest and most responsive bidder successively if the lowest bidder is not responsive or a purchase agreement cannot be negotiated with the top bidder; and

WHEREAS, funding for this request is available in the current Fiscal Year in the Vehicle Replacement Fund, "Capital Outlay – Vehicles" Account, Account No. 304.50005.500641.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:

<u>Section 1.</u> <u>Recitals.</u> The above recitals are confirmed, adopted, and incorporated herein and made part hereof by this reference.

Section 2. Approval. The use of the Florida Sheriffs Association Contract No. FSA22-VEL30.0 contract, which was competitively entered into in a matter similar to that set forth in Chapter 2, Article V of the City Code, for the purchase of a 2023 Ford Police Interceptor from the Vehicle Replacement Fund "Capital Outlay – Vehicles" Account Num. 304.50005.500641 in amount not to exceed budgeted funds, is hereby approved.

Section 3. Authorization. The City Manager is authorized to purchase the vehicle and expend budgeted funds on behalf of the City. The City Manager is further authorized to negotiate and enter into a purchase agreement with the next lowest and most responsive bidder successively if an agreement cannot be entered into with lowest bidder.

<u>Section 4.</u> <u>Implementation.</u> The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and provisions of this Resolution.

<u>Section 5.</u> <u>Effective Date.</u> This Resolution shall become effective immediately upon its adoption.
