

RESOLUTION NO. 14-147

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING A SITE PLAN MODIFICATION TO THE LANDMARK AT DORAL SITE PLAN APPROVED PURSUANT TO CITY OF DORAL RESOLUTION NO. Z05-39 AND RESOLUTION NO. 13-131, A VARIANCE FROM SECTION 68-507(3)(I) OF THE LAND DEVELOPMENT CODE TO PERMIT A HEIGHT OF 81.6 FEET FROM THE 75-FEET APPROVED VIA RESOLUTION NO. 13-13 WHICH WAS GRANTED IN LIEU OF A MAXIMUM HEIGHT OF 35 FEET IN THE ROWHOUSE USE CATEGORY, AND A MODIFICATION TO THE SECOND AMENDED AND RESTATED DECLARATION OF RESTRICTIONS RECORDED IN MIAMI-DADE COUNTY OFFICIAL RECORDS, BOOK 28578, PAGE 2545, FOR THE PROPERTY GENERALLY LOCATED EAST OF NW 107TH AVENUE BETWEEN NW 104 AVENUE AND NW 107 AVENUE AND BETWEEN NW 58TH STREET AND THEORETICAL NW 62ND STREET, PROVIDING FOR RECORDATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, EHOL Congress Doral LLC, owner, has requested a Site Plan Modification to the Landmark at Doral Site Plan, a Variance from Section 68-507(3)(i) of the LDC to permit a height of 81.6 feet from the 75-feet approved via Resolution No. 13-131 which was granted in lieu of a maximum height of 35-feet in the rowhouse use category, and a modification to the existing Declaration of Restrictive Covenants recorded in Miami-Dade County Official Records Book 28578, Page 2545, to incorporate the modified site plan for the property generally located East of NW 107th Avenue between NW 104 Avenue and NW 107 Avenue, and between NW 58th Street and theoretical NW 62 Street, Doral, Florida (Exhibit A); and

WHEREAS, City of Doral Resolution No. Z05-39 and Resolution No. 13-131 approved the site plan for Landmark at Doral Traditional Neighborhood Development; and

WHEREAS, the proposed modification will maintain the approved 631 dwelling units and 60,000 square feet of commercial uses as approved; and

WHEREAS, on September 17, 2014 the City Council held a public hearing and after careful review and deliberation, including a review of staff's recommendation, determined that it is in the best interests of the citizens of the City of Doral;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA THAT:

Section 1. Recitals. The above recitals are true, correct, and incorporated herein by this reference.

Section 2. Approval. The City Council of the City of Doral hereby approves the (1) site plan modification approved under City of Doral Resolution No. Z05-39 and Resolution No. 13-131, (2) variance from Section 68-507(3)(i) of the LDC to permit a height of 81.6 feet from the 75-feet approved via Resolution No. 13-131 which was granted in lieu of a maximum height of 35-feet in the rowhouse use category and (3) a modification to the existing Declaration of Restrictive Covenants recorded in Miami-Dade County Official Records Book 28578, Page 2545, to incorporate the modified site plan for the property generally located East of NW 107th Avenue between NW 104 Avenue and NW 107 Avenue, and between NW 58th Street and theoretical NW 62 Street, Doral, Florida subject to the following conditions:

- a. All applicable impact fees shall be paid by the Applicant prior to issuance of a building permit.
- b. The proposed project shall be built in substantial conformance with the plans entitled Landmark at Doral, prepared by Cohen, Freedman, Encinoso & Associates, Inc., dated September 5, 2014, consisting of 17 sheets date received September 5, 2014, as amended (Exhibit B).
- c. The Property shall be landscaped in accordance with the landscape plan, prepared by Witkin, Hults Design Group, dated September 4, 2014, consisting of 8 sheets, as amended, and included with the site plan submittal (Exhibit B).
- d. Pursuant to Section 14 of the Declaration of Restrictions provide the City the right of refusal pertaining to the conveyance of the library site (Exhibit C).

- e. All commercial deliveries shall be between the hours 7:00 am and 9:00 pm.
- f. Issuance of this development permit by the City of Doral does not in any way create any right on the part of an Applicant to obtain a permit from a state or federal agency and does not create any liability on the part of the City of Doral for issuance of the permit if the applicant fails to obtain requisite approvals or fulfill the obligations imposed by a state or federal agency or undertakes actions that result in a violation of state or federal law.
- g. All applicable local, state and federal permits must be obtained before commencement of the development.
- h. Flood elevations shall be reviewed and approved for consistency with FEMA requirements and the City Floodplain Management Ordinance prior to building permit approval.
- i. The Applicant shall comply with applicable conditions and requirements provided by Miami-Dade County Public Works Department, Water and Sewer Department, Fire Rescue Department, and Regulatory and Economics Resources (DRER) prior to issuance of building permit.
- j. The hours of operation during the construction shall adhere to as per Noise Ordinance No. 2011-01.
- k. The Applicant shall submit a construction staging plan for review and approval prior to commencement of construction. The staging area shall be kept clean at all times, adequately screened and located away from view of existing homes located adjacent to the construction site.
- l. Access points for construction vehicles shall be identified as part of the construction plan submitted to the City. Construction vehicles with access to site shall adhere to existing “no thru truck” areas.
- m. The Applicant shall provide a Construction Air Quality Management Plan to the Department prior to the start of construction.
- n. A Stormwater Pollution Prevention Plan (SPPP) must be submitted by the Applicant at time of building permit. The Plan should provide guidelines for implementing an erosion and sedimentation control program before the site is cleared or graded, including areas where top soil will be removed and contours of slopes will be cleared. The Plan shall also include location and type of erosion control measures, storm water and sediment management systems, and a vegetative plan for temporary and permanent stabilization. The Plan shall remain on-site for the duration of the construction activity.
- o. The Applicant shall preserve existing trees (including native trees) during the development of the project, wherever possible. If the trees must be removed, the Applicant shall be required to mitigate the impact in accordance with DRER requirements. If the relocated trees do not survive, the Applicant shall be required to replace the trees in compliance with DRER requirements.
- p. The Applicant shall meet the requirements of the Miami-Dade County Water-Use Efficiency Standards Manual, effective January 2009, as may be amended from time to time.

- q. All stormwater shall be retained on site in accordance with applicable law.
- r. All stormwater drainage systems shall be maintained in working conditions at all times in order to avoid localize flooding during and after a storm. Parking shall be prohibited on top of any drainage inlet or drainage manhole.
- s. If more than one (1) acre of land is disturbed during construction the Contractor/Developer is responsible to obtain NPDES Stormwater permit coverage through the Florida Department of Environmental Protection (FDEP) Construction Generic Permit (CGP). If the project is less than one (1) acre, but part of a larger common plan of development or sale that will ultimately disturb one or more acres, permit coverage is also required. Instruction to request and obtain a CGP can be found at: <http://www.dep.state.fl.us/water/stormwater/npdes/docs/cgp.pdf>. Contractor/Developer should submit the Notice of Intent (NOI) with the appropriate processing fees to the NPDES Stormwater Notices Center. Contractor/Developer must apply for permit coverage at least two (2) days before construction begins.
- t. The following conditions from the Public Works Department must be addressed prior to the Platting and/or the Paving & Drainage Plans review processes:
 - Miami-Dade County Public Works approval is required for driveways and intersecting streets connecting to NW 107 Avenue and to NW 58 Street. Both roads are section line roads and Miami-Dade County rights-of-way. A Traffic Study may be required. Turn lanes (and associated R/W dedications), median modifications, traffic signal(s), etc., may also be required.
 - Fire Department approval is required.
 - NW 62 Street roadway connection is required east adjacent to Doral Cay, and north into Landmark North. Ensure proper alignment at connection points.
 - Traffic Calming Devices may be required for long segments of internal private drives.
- u. Noncompliance with the approved site plan and the terms of this approval shall be considered a violation of the City Code. Penalties for such violation(s) shall be prescribed by the City Code.

Section 3. Recordation. This Resolution shall be recorded in the Public Records of Dade County, Florida, with the Applicant to pay the costs thereof.

Section 4. Effective Date. This resolution shall become effective upon its passage and adoption by the City Council.

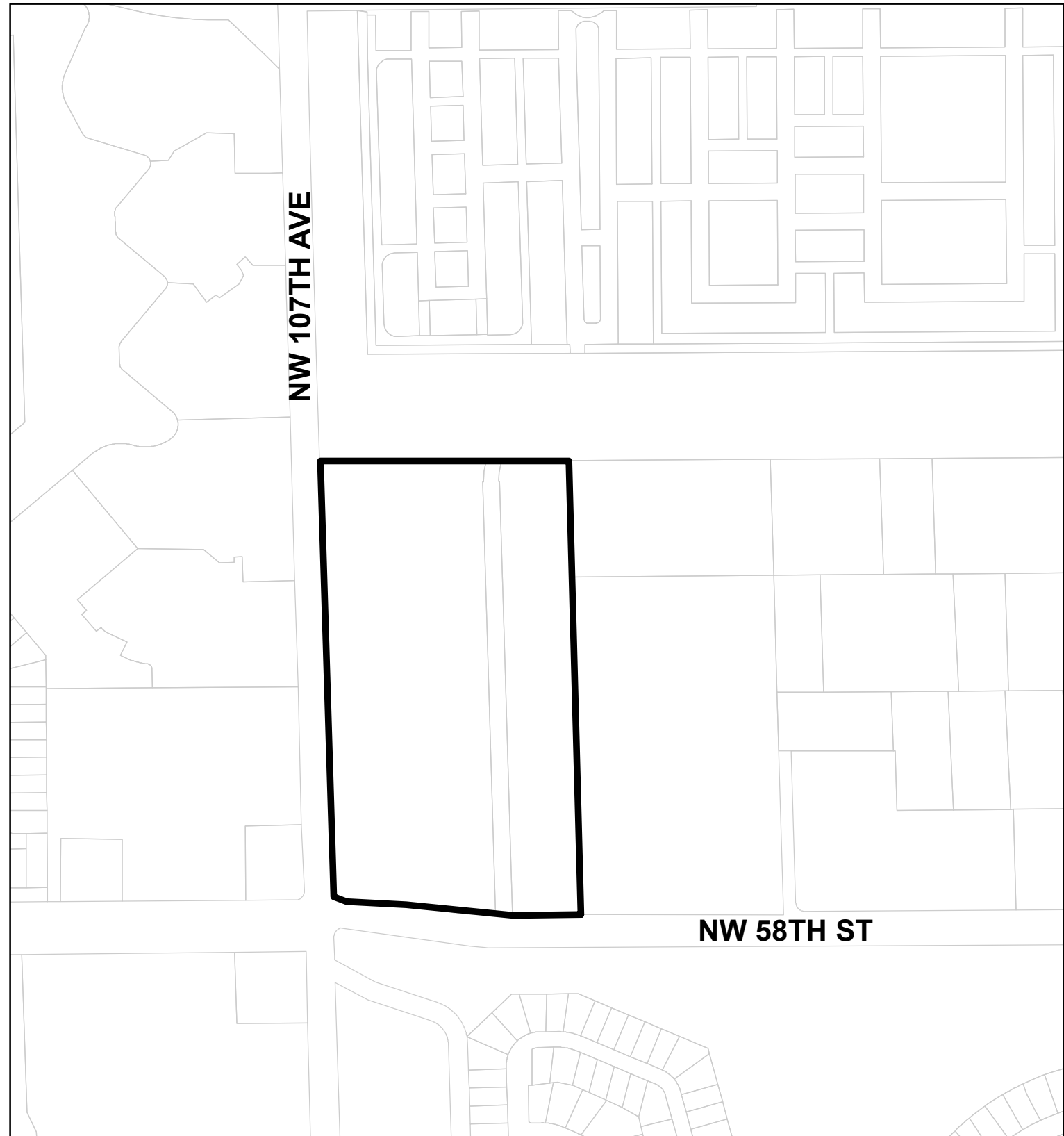

**RE: Amended Letter of Intent Landmark at Doral TND - Modification
of the Site Plan – South Parcel and Resolution Number 13-131**

Dear Mr. Perez:

This letter shall constitute our Amended Letter of Intent on behalf of EHOFC Congress Doral, LLC (the "Applicant") for its application for approval of a modification to the Landmark at Doral TND (the "TND") Site Plan and Modification to Resolution Number 13-131. The Applicant is seeking a modification of the project Site Plan for the south 25.24 acres of the TND.

The TND currently consists of approximately +/-102 acres located between NW 102nd Avenue and NW 107th Avenue and between NW 58th Street and theoretical NW 67th Street (the "TND") and is divided into two parcels: the north +/-80.8 acres located between NW 103rd Avenue and NW 107th Avenue and between NW 62nd Street and theoretical NW 67th Street owned by Lennar Homes, LLC ("North Parcel") and the south +/-21 acres located between NW 104th Avenue and NW 107th Avenue and between NW 58th Street and NW 62nd Street; owned by the Applicant ("South Parcel"). The Site Plan for the South Parcel currently consists of 631 residential dwelling units and 60,000 square feet of commercial uses. The proposed Site Plan maintains the 631 residential units and 60,000 square feet of commercial uses, but seeks to modify the Site Plan for the South Parcel and Resolution Number 13-131 to slightly increase the height of the rowhouse use from 75 feet to 81.4 feet.

The Applicant believes it must incorporate fewer studios and more two (2) and three (3) bedroom units in the Landmark at Doral TND. Market research shows that this configuration is more in line with the demand in the area. To accommodate this new

design that better serves the needs of Doral residents, the Applicant is requesting to modify Resolution 13-131 to allow the **rowhouse use** a maximum height of 81.4 feet instead of the 75 feet currently allowed by this Resolution.

The Applicant seeks the approval of the Site Plan in order to ensure compliance with Section 68-473 of the City's Land Development Code as it relates to the TND site plan review requirements. The Site Plan provides a general site layout showing the proposed density, theoretical circulation and access, and the site legend and data tables required for the South Parcel. The Site Plan was previously submitted by the Applicant and has been reviewed by the City for consistency with Code requirements.

On April 27, 2014, the Applicant submitted a revised Site Plan and Landscape Plan to the Department of Planning and Zoning, incorporating the City's comments as communicated to the Applicant in a letter dated August 21, 2014, and at related meetings with the Planning and Zoning Department and the Public Works Department on August 25, 2014.



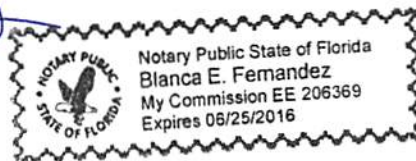

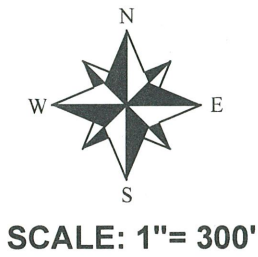
