A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AUTHORIZING THE CITY MANAGER TO PURCHASE ONE (1) MOBILE LPR 3-CAMERA REAPER HIGH-DEFINITION SYSTEM FROM VETTED SECURITY SOLUTIONS, WHO CAN BE VIEWED AS A SOLE SOURCE PROVIDER AS VIGILANT SOLUTIONS EXCLUSIVE AND PREFERRED RESELLER IN THE STATE OF FLORIDA, IN AN AMOUNT NOT TO EXCEED BUDGETED FUNDS; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral Police Department respectfully requests to purchase one (1) mobile LPR 3-camera reaper high definition system from Vetted Security Solutions, as a sole source provider; and

WHEREAS, the Mobile License Plate Recognition (LPR) System is a complete solution that can be deployed on any vehicle in our fleet and easily operated by any driver. It enables the Officers to receive real-time alerts, conduct comprehensive searches and it's paired with Vigilant PlateSearch or Vigilant ClientPortal which are actively in use.

WHEREAS, Staff respectfully requests that the Mayor and City Council members authorize the City Manager on behalf of the City to purchase one (1) mobile LPR 3-camera reaper high definition systems from Vetted Security Solutions in an amount not to exceed budgeted funds from Capital Outlay-Other Police Impact Fee Expenses, Account No. 103.60005.500652; and

WHEREAS, Pursuant to Section 2-321 of the City Code, we respectfully request authorization for the City Manager to waive competitive bidding procedures to purchase one (1) mobile LPR 3-camera reaper high definition systems from Vetted Security

Solutions in an amount not to exceed budgeted funds. Vigilant Solutions has provided a sole source letter for Vetted Security Solution which is the only designated certified reseller for Vigilant Solutions LPR Hardware for State and Local Governments in the State; and

NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:

<u>Section 1.</u> Recitals. The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

Section 2. Authorization. The City Manager is hereby authorized to purchase one (1) mobile LPR 3-camera reaper high-definition systems from Vetted Security Solutions in an amount not to exceed budgeted funds from Capital Outlay-Other Police Impact Fee Expenses, Account No. 103.60005.500652. Vigilant Solutions has provided a sole source letter for Vetted Security Solution which is the only designated certified reseller for Vigilant Solutions LPR Hardware for State and Local Governments in the State.

<u>Section 3.</u> <u>Implementation.</u> The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and provisions of this Resolution.
