A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING A WORK ORDER BETWEEN THE CITY OF DORAL AND DAVID PLUMMER & ASSOCIATES, A PREQUALIFIED CITY VENDOR, FOR THE PROVISION OF STORMWATER IMPROVEMENTS DESIGN AND PERMITTING SERVICES FOR SUB BASIN D-79 AVE, A PORTION OF YEAR 4 OF THE STORMWATER MASTER PLAN CAPITAL IMPROVEMENT PLAN IN AN AMOUNT NOT TO EXCEED \$50,718.00; AUTHORIZING THE CITY MANAGER TO EXECUTE THE WORK ORDER AND EXPEND BUDGETED FUNDS ON BEHALF OF THE CITY; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, on March 12, 2014, the 2013 Stormwater Master Plan ("SMP") and the proposed 5-Year Capital Improvement Plan ("CIP") was adopted by City Council of the City of Doral (the "City") via Resolution No. 14-52; and

WHEREAS, the City wishes to secure a firm to provide design and permitting services for stormwater improvements at Sub Basin D-79Ave of the Stormwater Master Plan; and

WHEREAS, David Plummer & Associates (David Plummer) is a pre-qualified provider of professional engineering services selected in accordance with Consultant Competitive Negotiation Act requirements and approved by the City Council in December 2014; and

WHEREAS, City staff has recommended that the City Council approve Work Order No. 9 for David Plummer, a copy of which is attached hereto as Exhibit "A", for the provision of design and permitting services for stormwater improvements at Sub Basin D-79Ave in a not to exceed amount of \$50,718.00.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

Section 4. Implementation. The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and the provisions of this Resolution.

The City of Doral authorizes the firm of David Plummer & Associates to proceed with design of stormwater improvements for Sub Basin D-79Ave, a portion of Year 4 of the 5-Year Capital Improvement Plan proposed on the 2013 Stormwater Master Plan Update as of the date of this Work Order. The work should be performed in accordance with the contract provisions contained in the Continuing Professional Services Agreement between David Plummer & Associates and the City of Doral dated February 2, 2015, and the attached Proposal submitted by your firm for the above referenced project.

SCOPE OF SERVICES AND SCEHDULE:

The scope of the project will be as described in the attached proposal from David Plummer & Associates dated July 25, 2016, to provide professional engineering services which include: surveying, geotechnical testing, design, cost estimate, and permitting for Sub Basin D-79Ave of the Stormwater Master Plan adopted in March 2014. The schedule requires the work to be performed within one hundred and eighty (180) calendar days from the notice to proceed. The performance of services associated with this Work Order will be executed on a time and materials basis with a not to exceed amount of \$50,718.00.

You are required by the Continuing Service Agreement to begin work subsequent to the execution of this Work Order, or as directed otherwise. If you fail to begin work subsequent to the execution of this Work Order, the City of Doral will be entitled to disqualify the Proposal, and revoke the award.

Work Order incorporates the terms and conditions set forth in the Continuing Services Agreement dated February 2, 2015 between the parties as though fully set forth herein. In the event that any terms or conditions of this Work Order conflict with the Continuing Services Agreement, the provisions of this specific Work Order shall prevail and apply.

Work Order is not binding until the City of Doral agrees and approves this Work Order.
