

**RESOLUTION No. 10 – 77**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA RATIFYING THE RENEWAL OF THE “ADOPT-A-STREET” PROGRAM LITTER REMOVAL AGREEMENT WITH WESTVEST ASSOCIATES, INC. FOR THE PROVISION OF LITTER-REMOVAL SERVICES ALONG N.W. 79 AVENUE FROM N.W. 25 STREET TO N.W. 36 STREET; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, the City of Doral, through Resolution #05-12, established an “Adopt-A-Street” Program permitting local organizations, private corporations and volunteer groups to beautify City-maintained roads through litter-removal activities and landscaping efforts; and

**WHEREAS**, in April 2008, the City Council ratified a two (2)-year Adopt-A-Street Litter-Removal Agreement with WestVest & Associates, Inc. (WestVest) for litter-removal activities along N.W. 79 Avenue between N.W. 25 Street to N.W. 36 Street ; and

**WHEREAS**, WestVest wishes to renew said agreement for an additional two (2) years; and

**WHEREAS**, Staff respectfully requests that the City Council ratify the renewal of the Adopt-A-Street Program Litter Removal Agreement with WestVest for the provision of litter-removal activities along the roadway mentioned in the above “whereas” clause.

**NOW THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:**

**Section 1.** The City Council of the City of Doral hereby ratifies the renewal of the Adopt-A-Street Program Litter Removal Agreement with WestVest for the provision of litter-removal activities along N.W. 79 Avenue between N.W. 25 Street to N.W. 36 Street.

**Section 2.** This Resolution shall take effect immediately upon adoption.
