RESOLUTION NO. 12-75

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE DORAL, FLORIDA AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND ENTER INTO AN AGREEMENT WITH KIMLEY, HORN & ASSOCIATES, INC. FOR THE PROVISION OF DESIGN SERVICES FOR STORMWATER AND RELATED ROADWAY IMPROVEMENTS FOR N.W. 117TH AVENUE FROM N.W. 50TH STREET TO N.W. 58TH STREET IN AN AMOUNT NOT TO EXCEED \$79,800.00; RECOGNIZING THAT KIMLEY, HORN & ASSOCIATES IS A CITY OF DORAL PRE-QUALIFIED VENDOR; AND PROVIDING FOR AN EFFECTIVE DATE (PUBLIC WORKS)

WHEREAS, the City of Doral Public Works Department is searching for a firm to provide design services for stormwater and related roadway improvements along N.W. 117th Avenue; and

WHEREAS, Staff has determined that Kimley, Horn and Associates, Inc., one of ten (10) City of Doral pre-qualified vendors for professional engineering services, would be best qualified to offer these services; and

WHEREAS, Staff respectfully requests that the City Council authorize the City Manager to negotiate and enter into an agreement with Kimley, Horn and Associates, Inc. for the provision of design services for stormwater and related roadway improvements for N.W. 117th Avenue from N.W. 50th Street to N.W. 58th Street in an amount not to exceed \$79,800.00.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:

<u>Section 1.</u> Recognizing that Kimley, Horn and Associates, Inc. is a City of Doral pre-qualified vendor, the City Council of the City of Doral hereby authorizes the City Manager to negotiate and enter into an agreement with Kimley, Horn and Associates, Inc. for the provision of design services for stormwater and related roadway improvements for N.W. 117th Avenue from N.W. 50th Street to N.W. 58th Street in an amount not to exceed \$79,800.00.

Section 2. This Resolution shall become effective immediately upon adoption.
