

**RESOLUTION No. 17-185**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, PURSUANT TO SECTION 2-322 OF THE CITY CODE OF ORDINANCES, APPROVING THE PURCHASE OF 24 POLICE VEHICLES IN AN AMOUNT NOT TO EXCEED \$523,439.20 VIA THE AGREEMENT WITH THE STATE OF FLORIDA CONTRACT NO. 25100000-16-1 AND GARBER FLEET SALES; AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND ENTER INTO AN AGREEMENT, SUBJECT TO APPROVAL AS TO FORM AND LEGAL SUFFICIENCY BY THE CITY ATTORNEY, FOR THE PURCHASE; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, the Police Department for the City of Doral (the “City”) seeks to purchase 24 vehicles from Garber Fleet Sales as follows: Eight (8) Police Service Aides, (15) Uniform Patrol Sedans and One (1) Police Truck; and

**WHEREAS**, Staff respectfully requests that the City Council authorize the City Manager to negotiate and enter into an agreement with Garber Fleet Sales for the purchase of 24 police vehicles in an amount not to exceed \$523,439.20 via Garber Fleet Sales and the State of Florida contract which was competitively entered into in a manner similar to that set forth in Chapter 2, Article V of the City Code; and

**NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:**

**Section 1. Recitals.** The foregoing recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

**Section 2. Approval.** Pursuant to section 2-322 of the City Code of Ordinances, the purchase of 24 police vehicles in an amount not to exceed \$523,439.20 via the State of Florida Agreement with Garber Fleet Sales. This purchase is funded in accounts 103.60005.500641 Impact Fee-Capital Outlay in the amount of \$249,364.00

and 001.60005.500641 Police Budget-Capital Outlay-Vehicles in the amount of \$274,075.20 for a total of \$523,439.20.

**Section 3. Authorization.** The City Manager is hereby authorized to enter into an agreement and other contractual documents, subject to approval as to form and legal sufficiency by the City Attorney, as may be necessary to procure the Vehicles under the State of Florida contract with Garber Fleet Sales, and to expend funds in furtherance thereof in amounts not to exceed \$523,439.20.

**Section 4. Implementation.** The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and provisions of this Resolution.

**Section 5. Effective Date.** This Resolution shall become effective immediately upon its adoption.

The foregoing Resolution was offered by Councilmember Rodriguez who moved its adoption. The motion was seconded by Councilmember Mariaca and upon being put to a vote, the vote was as follows:
