A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL FLORIDA. PURSUANT TO SECTION 2-322 OF THE CITY CODE OF ORDINANCES, APPROVING A PURCHASE INSTALLATION OF OFFICE FURNITURE RELOCATION OF THE PARKS AND RECREATION DEPARTMENT IN THE GOVERNMENT CENTER FROM AFFORDABLE INTERIOR SYSTEM, IN AN AMOUNT NOT TO EXCEED \$56,464.61, PURSUANT TO STATE OF **FLORIDA** EDUCATIONAL/ INSTITUTIONAL FURNITURE CONTRACT NO. 420-420-10-1 FOR OFFICE FURNITURE AND CHAIRS AND CONTRACT NO. 425-001-12-1 FOR WORKSTATIONS, WHICH WAS COMPETITIVELY ENTERED INTO IN A MANNER SIMILAR TO THAT SET FORTH IN CHAPTER 2, ARTICLE V, OF THE CITY CODE; AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND ENTER INTO AN AGREEMENT, SUBJECT TO APPROVAL BY THE CITY ATTORNEY AS TO FORM AND LEGAL SUFFICIENCY. AND TO EXPEND BUDGETED FUNDS ON BEHALF OF THE CITY WITH RESPECT TO THE PURCHASE AND INSTALLATION OF OFFICE FURNITURE: PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN **EFFECTIVE DATE**

WHEREAS, in the December 10, 2014 City Council Meeting, the City Council for the City of Doral (the "City") adopted Resolution No. 14-199 authorizing the City Manager to execute a work order with State Contracting & Engineering Corporation for the renovation of vacant space on the first floor of the Government Center for the relocation of the Parks & Recreation department;

WHEREAS, in furtherance thereof, the City issued invitation to bid No. 2015-17 "Office Furniture" (the "ITB") on June 3, 2015 for the purchase of office furniture associated with the relocation of the Parks & Recreation department to the first floor, with a mandatory pre-bid meeting held on Wednesday, June 24, 2015; and

WHEREAS, on July 8, 2015 bid opening, the City's Procurement Department confirmed that no submittals were received responsive to the ITB; and

WHEREAS, Pradere Office Products, the original provider of furniture for the Government Center, is an authorized dealer for sales and installation of Affordable Interior Systems ("AIS"), which is a cost effective office furniture line comparable to the existing furniture in the Government Center; and

WHEREAS, AIS holds the State of Florida Educational / Institutional Furniture Contract No. 420-420-10-1 for office furniture and chairs and Contract No. 425-001-12-1 for workstations, copies of which are attached as Composite Exhibit "A" (the "AIS State Contracts"), and which were competitively entered in a manner similar to that set forth in Chapter 2, Article V, of the City Code;

WHEREAS, in light of the lack of response to the City's own competitive procurement efforts, staff has recommended that the City Council authorize the City Manager to enter into an agreement with Pradere Office Products for the purchase and installation of office furniture/work stations for the relocation of the Parks & Recreation Department to the first floor of the Government Center in an amount not to exceed \$56,464.61, pursuant to the AIS State Contracts.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

<u>Section 1.</u> Recitals. The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

Section 2. Approval. Pursuant to the section 2-322 of the City Code, the purchase and installation of office furniture and work stations for the relocation of the Parks & Recreation Department, from Pradere Office Products pursuant to the AIS State Contracts, is hereby approved in an amount not to exceed \$56,464.61. The City Manager is authorized to negotiate with, and enter into, an agreement with Pradere Office Products,

subject to approval by the City Attorney as to form and legal sufficiency, for the purchase and installation of office furniture/work stations for the relocation of the Parks & Recreation Department to the first floor of the Government Center in an amount not to exceed \$56,464.61. This approval does not create any vested rights in Pradere Office Products or any third party.

<u>Section 3.</u> <u>Implementation.</u> The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and the provisions of this Resolution, including, but not limited to, budget transfers to amass the requisite funds.

<u>Section 4.</u> <u>Effective date.</u> This Resolution shall take effect immediately upon adoption.


