

ORDINANCE #2010- 13

AN ORDINANCE OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, PROVIDING FOR THE AMENDMENT AND INCREASE OF THE CITY GENERAL FUNDS BUDGET FOR FISCAL YEAR 2009-2010 FROM DESIGNATED AND RESERVED IMPACT FEE FUND BALANCE ; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral (the "City") finds it necessary to adjust certain budget items in the City's General Funds Budget for Fiscal Year 2009-2010 (the "Budget");

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

Section 1. The General Fund Budget is hereby amended and increased in the amount of \$840,940.00 by the inclusion of an appropriation to the following line item Budgets

Parks & Recreation – Capital Improvements Parks - Account 001.9000.500634:

\$840,490.00

These funds are to be re-allocated from the General Funds Unrestricted Fund Balance but as Designated and Reserved Impact Fee's for Park development use. Pursuant to Article IV Section 4.06 of the City Charter whereby a supplemental appropriation is being made from the Undesignated and Unrestricted Fund Balance of the General Fund.

Section 2. Severability. The provisions of this Ordinance are declared to be severable and if any section, sentence, clause or phrase of this Ordinance shall for any reason be held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining sections, sentences, clauses, and phrases of this Ordinance but they shall remain in effect, it being the legislative intent that this Ordinance shall stand notwithstanding the invalidity of any part.

Section 3. Effective Date. This Ordinance shall be effective upon adoption on second reading.

The foregoing Ordinance was offered by Councilman Cabrera who moved its adoption. The motion was seconded by Vice Mayor Van Name and upon being put to a vote, the vote was as follows:
