

RESOLUTION No.16-101

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING A PURCHASE PURSUANT TO SECTION 2-322 OF THE CITY CODE OF ORDINANCES FOR THE PROVISION OF ONE (1) FORD T-150 CARGO VAN, E1Z FOR THE PUBLIC WORKS DEPARTMENT; PURSUANT TO THE FLORIDA SHERIFFS ASSOCIATION AND FLORIDA ASSOCIATION OF COUNTIES CONTRACT NO. 15.23.0904 IN AN AMOUNT NOT TO EXCEED \$23,570.00; AUTHORIZING THE CITY MANAGER TO EXPEND BUDGETED FUNDS ON BEHALF OF THE CITY; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral Public Works Department seeks to purchase one 2016 Ford T-150 Cargo Van, E1Z to address the added demands of the facilities maintenance work performed by the Public Works Department; and

WHEREAS, pursuant to section 2-322 of the City Code, Duval Ford Fleet Sales holds Contract No. 15.13.0904 Utility Cargo Van Specification # 33 with Florida Sheriffs Association & Florida Association of Counties which was competitively entered in a manner similar to that set forth in Chapter 2, Article V, of the City Code, a copy of which is attached as Exhibit "A"; and

WHEREAS, staff recommends that the City Council authorize the City Manager to enter into an agreement with Duval Ford Fleet Sales for the purchase of one (1) 2016 Ford T-150 Cargo Van, E1Z for the use of the Public Works Department in a total amount not to exceed \$23,570.00.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The above recitals are confirmed, adopted, and incorporated herein and made part hereof by this reference.

Section 2. Approval. The City Council hereby authorizes the City Manager to enter into an agreement with Duval Ford Fleet Sales for the purchase of one 2016 Ford T-150 Cargo Van, E1Z for the use of the Public Works Department in a total amount not to exceed \$23,570.00.

Section 3. Implementation. The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and the provisions of this Resolution.

Section 4. Effective Date. This Resolution shall take effect immediately upon adoption.
