

**RESOLUTION No. 22-73**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA AUTHORIZING THE CITY MANAGER TO EXECUTE A WORK ORDER WITH AP CONSULTING TRANSPORTATION ENGINEERS TO PROVIDE POST DESIGN SERVICES FOR THE CONSTRUCTION PHASE OF THE DORAL BOULEVARD MEDIAN LANDSCAPE IMPROVEMENTS PHASE II IN AN AMOUNT NOT TO EXCEED \$23,640.87; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, on August 9, 2016, the City of Doral authorized the firm of Keith and Schnars, P.A. (currently named KCI Technologies Inc.) to proceed with the provisions of professional design services and the development of construction plans for the landscape improvements within the Doral Boulevard median from NW 97<sup>th</sup> Avenue to the Palmetto Expressway Interchange via Work Order #5 for an amount not to exceed \$123,344.81; and

**WHEREAS**, on July 11, 2019, the City of Doral authorized the firm of A&P Consulting Transportation Engineers to provide professional engineering services for the analysis of the medians along Doral Boulevard to study the limitations for landscaping and prepare a presentation for the Mayor and Council members; and

**WHEREAS**, on March 8, 2022, A&P Consulting Transportation Engineers provided a proposal for Post Design Services in a not to exceed amount of \$23,640.87; and

**WHEREAS**, A&P Consulting Transportation Engineers is a prequalified provider of professional engineering services selected in accordance with Consultant Competitive Negotiation Act (CCNA) requirements and approved by the City Council in October 2020 through Resolution 20-243; and

**WHEREAS**, the work should be performed in accordance with the contract provisions contained in the Continuing Professional Services Agreement between A&P

Consulting Transportation Engineers and the City of Doral dated January 1, 2020, and the attached Proposal dated March 8, 2022; and

**WHEREAS**, staff respectfully requests to execute Work Order No. 9 for A&P Consulting Transportation Engineers to provide Post Design Services for Doral Boulevard Median Improvements in an amount not to exceed \$23,640.87, a copy of which is attached as Exhibit “A”; and

**WHEREAS**, Funding for Post Design Services of “Doral Boulevard Median Landscaping Improvements Phase II” is available in the current Fiscal Year in the Public Works Fund, Account No. 001.80005.500650.

**NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:**

**Section 1. Recitals.** The above recitals are true and correct and incorporated herein.

**Section 2. Approval.** The work order between the City and A&P Consulting Transportation Engineers to provide Post Design Services of ITB 2022-05 Doral Boulevard Median Landscaping Improvements Phase II in an amount not to exceed \$23,640.87 as to form and legality by the City Attorney, is hereby approved.

**Section 3. Authorization.** The City Manager is authorized to execute the work order with A&P Consulting Transportation Engineers and expend budgeted funds on behalf of the City in furtherance hereof.

**Section 4. Implementation.** The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and the provisions of this Resolution.

**Section 5. Effective Date.** This Resolution shall take effect immediately upon

adoption.

**SCOPE OF SERVICES AND SCEHDULE:**

The scope of the project will be as described in the attached proposal from A&P Consulting Transportation Engineers dated March 8, 2022, for “Post Design” services of ITB 2022-05 - Doral Boulevard Median Landscaping Improvements. The schedule requires the scoped of work to be completed within 150 days as of Notice to Proceed. All limitations of time set forth in this Work Order are of the essence. The performance of services associated with this Work Order will be executed on a time and material basis not to exceed the amount of \$23,640.87.

You are required by the Continuing Service Agreement to begin work subsequent to the execution of this Work Order, or as directed otherwise. If you fail to begin work subsequent to the execution of this Work Order, the City of Doral will be entitled to disqualify the Proposal and revoke the award.

Work Order incorporates the terms and conditions set forth in the Continuing Services Agreement dated January 1, 2020 between the parties as though fully set forth herein. In the event that any terms or conditions of this Work Order conflict with the Continuing Services Agreement, the provisions of this specific Work Order shall prevail and apply. Work Order is not binding until the City of Doral agrees and approves this Work Order.

IN WITNESS WHEREOF, the parties hereto have executed this Agreement on the day and date first above written, in three (3) counterparts, each of which shall, without proof or accounting for the other counterpart be deemed an original Contract.
