A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AUTHORIZING THE AWARD OF ITB#2014-35 "NW 114TH AVENUE PARK CONSTRUCTION TEMPORARY FENCING" TO CARLSON FENCE COMPANY, INC.; AUTHORIZING THE CITY MANAGER TO ENTER INTO AN AGREEMENT FOR THE INSTALLATION, RENTAL, AND REMOVAL OF THE CONSTRUCTION TEMPORARY FENCE FOR NW 114TH AVENUE PARK IN AN AMOUNT NOT TO EXCEED \$95,000.00 FOR THE FIRST YEAR, WITH A FIVE (5%) PERCENT CONTINGENCY FOR ANY REPAIRS NEEDED AND ADDITIONAL TIME THEREAFTER TO BE BILLED MONTHLY AT \$7,916.67; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in response to ITB #2014-35 "NW 114th Avenue Park Construction

Temporary Fencing," (the "ITB") the City of Doral (the "City") received two (2) bids by the

September 14, 2014 deadline, with two (2) companies meeting the required criteria; and

WHEREAS, upon review of the bid received, Carlson Fence Company, Inc. was

deemed a responsive and responsible bidder; and

WHEREAS, Staff has recommended that the City Council authorize to award the

ITB to the Carlson Fence Company, Inc. and to authorize the City Manager enter into an

agreement for the provision and installation of the construction temporary fence for NW

114th Avenue Park.

NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

<u>Section 2.</u> <u>Approval of Services.</u> The award of the ITB to Carlson Fence Company, Inc. is approved, pursuant to an agreement of which shall not exceed \$95,000.00 for the first year, with a five (5%) percent contingency for any repairs needed and additional time thereafter to be billed monthly at \$7,916.67.

<u>Section 3.</u> <u>Authorization to Procure Services.</u> The City Manager is hereby authorized to enter into an agreement with Carlson Fence Company, Inc. on such terms and condition as may be appropriate to protect and further the interests of the City for this matter. This Authorization does not create or confer any rights to Carlson Fence Company, Inc.

Section 4. Implementation. The City Manager and the City Attorney are hereby authorized to take such action as may be necessary to implement the provisions of this Resolution.

Section 5. Effective Date. This resolution shall take effect immediately upon adoption.
