

**RESOLUTION No. 15-186**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING AN OUTDOOR EVENT PERMIT FOR UNIVISION NETWORK TO HOST THE “SABADO GIGANTE LIVE SHOW” EVENT ON THE PARKING FIELD OF UNIVISION NETWORK OFFICES AND STUDIOS ON SATURDAY, SEPTEMBER 19, 2015 FROM 5:00PM TO 11:00PM; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, the Univision Network (“Applicant”) seeks approval from the City of Doral (the “City”) for an Outdoor Event Permit; and

**WHEREAS**, staff has recommended that Council approve the Applicant’s proposed Outdoor Event Permit to host the “Sabado Gigante Live Show” on Saturday, September 19, 2015 from 5:00pm to 11:00pm on the parking field located at 9405 NW 41<sup>st</sup> Street, Doral, Florida 33178.

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:**

**Section 1. Recitals.** The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

**Section 2. Approval.** The outdoor event permit for the “Sabado Gigante Live Show” is hereby approved subject to the following conditions:

1. Applicant shall comply with the conditions proposed or adopted by the Mayor and City Council.
2. Applicant shall comply with the comments made by the City of Doral Police Department.
3. Applicant shall comply with acquiring all required permits and performing the necessary inspections prior to event start, given by the City of Doral Building Department.

4. Applicant shall comply with the comments made by the City of Doral Public Works Department.
5. Applicant shall provide the location and distance of the nearest restrooms from the main event area, prior to event.

**Section 4. Implementation.** The City Manager and City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and provisions of this Resolution.

**Section 5. Effective Date.** This Resolution shall take effect immediately upon adoption.

The foregoing resolution was offered by Councilmember Cabrera who moved its adoption. The motion was seconded by Vice Mayor Ruiz and upon being put to a vote, the vote was as follows:
