## **RESOLUTION NO. Z 04-15**

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING THE WAIVER OF PLAT OF A PORTION OF TRACT B OF PARK AT MICC PB 157 PG 25; ACCEPTING DEDICATIONS AND RESTRICTIONS; PROVIDING FOR CONDITIONS; AUTHORIZING TRANSMITTAL; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, PS Business Park L.P. has this day presented to the City of Doral Council (the "Council") a waiver plat of certain lands lying within the City of Doral, Florida (Exhibit "A"), said waiver of plat identified as D-21775; and

WHEREAS, all legal and technical requirements for approval of said waiver of plat insofar as the authority of this Council is concerned have been complied with.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The above recitals are true and correct and are incorporated herein by this reference.

Section 2. Waiver of Plat Approval. The waiver of plat is approved. The approval of the waiver of plat is not a waiver of any land use regulations and all land use regulations existing on the Plat lands at the time of this Resolution shall be enforced. The approval of this Plat is conditioned upon the proper execution of all documents required by the City Attorney's Office.

- Section 3. Conditions. The waiver of plat is approved subject to the following conditions and requirements.
  - a) That the applicant receive and submit to the City the final approval by Miami-Dade Public Works Department.
  - b) That the applicant prior to receiving final approval from Miami Dade

    County Public Works Department provide evidence that it has received vested rights approval from the City of Doral.

Section 4. Special Taxing District. Within 30 days from the effective date of this Resolution, the owner shall apply for a special taxing district for street light improvements with Miami-Dade County in accordance with the procedures outlined in Section 18-2 of the City of Doral and Miami-Dade County Code, if required. No building permit shall be issued for any portion of the platted property until the special taxing district is approved.

<u>Section 5</u> <u>Dedications.</u> The dedication of the streets, alleys, and other rights-of-way however designed or depicted on the waiver of plat, if any, and the restrictions as listed on the waiver of plat, if any are approved and are to be enforced.

Section 6. Transmittal. The City Clerk is hereby authorized to transmit to Miami-Dade County the executed Plat, a copy of this Resolution and instructions that the Plat is ready to be recorded.

Section 7. Effective Date. This resolution shall take effect immediately on its adoption.

The foregoing Resolution was offered by Vice Mayor Cabrera, who moved its adoption. The motion was seconded by Councilman DiPietro and upon being put to a vote, the vote was as follows:

BEGINNING at the Northeast corner of said Tract "B", Thence: South 90°00'00" West along the north line of said Tract "B" a distance of 862.07 feet to the Point of Beginning, Thence; continue South 90°00'00" West, along the north line of said Tract "B", a distance of 105.00 feet, Thence; South 00°00'00" East a distance of 124.49 feet to the point of curvature of a circular curve, concave to the Northeast and having a radius of 25.00 feet, Thence; Southeasterly and Northeasterly through a central angle of 130°00'00", an arc distance of 56.75 feet to a point of tangency, Thence; North 50°00'00" East a distance of 83.46 feet, Thence; North 00°00'00" West a distance of 90.00 feet to the Point of Beginning.
