

RESOLUTION No. 11 – 154

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA AUTHORIZING A CHANGE ORDER TO THE EXISTING AGREEMENT WITH GONZALEZ & SONS EQUIPMENT, INC. FOR THE CANAL BANK STABILIZATION PROGRAM YEAR III IN AN INCREASED AMOUNT OF \$247,703.70 AND FOR A TOTAL OVERALL AMOUNT NOT TO EXCEED \$1,426,589.70; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral City Council approved the extension of the Gonzalez & Sons Equipment, Inc. (G&S) agreement for the Canal Bank Stabilization Program to allow for construction of the Natural Resources Conservation Services (NRCS) granted portion of Year 3 of the Program in the amount of \$1,178,886.00; and

WHEREAS, upon receipt of the final set of drawings for the project which specified changes in materials and stabilization methods due to site conditions, etc., the cost for the completion of Year 3 has increased by approximately \$247,703.70 which are to be covered by the NRCS grant; and

WHEREAS, in order to be able to complete the granted portion of Year 3 of the Canal Bank Stabilization Program and comply with the schedule required by the grant, Staff respectfully requests that the City Council authorize a change order to the existing agreement with G&S for the Canal Bank Stabilization Program Year 3 in an increased amount of \$247,703.70 and for a total overall amount not to exceed \$1,426,589.70.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA AS FOLLOWS:

Section 1. The City Council hereby authorizes a change order to the existing agreement with G&S for the Canal Bank Stabilization Program Year 3 in an increased amount of \$247,703.70 and for a total overall amount not to exceed \$1,426,589.70.

Section 2. This Resolution shall take effect immediately upon adoption.


