SCOPE OF SERVICES AND SCEHDULE:

The performance of services associated with this Work Order will be executed on a time and material basis not to exceed the amount of \$30,107.00.

You are required by the Continuing Service Agreement to begin work subsequent to the execution of this Work Order, or as directed otherwise. If you fail to begin work subsequent to the execution of this Work Order, the City of Doral will be entitled to disqualify the Proposal and revoke the award.

Work Order incorporates the terms and conditions set forth in the Continuing Services Agreement dated January 4, 2021, between the parties as though fully set forth herein. In the event that any terms or conditions of this Work Order conflict with the Continuing Services Agreement, the provisions of this specific Work Order shall prevail and apply. Work Order is not binding until the City of Doral agrees and approves this Work Order.

(APCTE) FOR THE PROVISION OF DESIGN. DEVELOPMENT OF CONSTRUCTION DOCUMENTS. WHEREAS, as the City continues to grow, there is a need for the City's Government
Center to adapt and transform in order to address the needs of a growing staff and ensure
that the best possible service is provided to the community; and

WHEREAS, in 2014, the City of Doral performed a space planning study for the Government Center in order to provide guidance for future improvements to the facility; and

WHEREAS, during the Fiscal Year 2021-22 Budget Cycle, the City Manager's Office provided a directive to recondition the existing space area in the northeast side of the third level within the Doral Government Center Building for the Public Affairs Department to expand for new office space, additional workstations, recording studio, and additional storage; and

WHEREAS, the Public Works Department (PWD) requested a proposal from A&P Consulting Transportation Engineers (APCTE) for these purposes; and

WHEREAS, APCTE submitted the attached proposal which includes the design and development of construction documents for the new Public Affairs area; and

WHEREAS, the scope of the proposed project includes design and development of construction drawings and associated permitting process, in an amount not to exceed \$30,107.00; and

WHEREAS, the PWD respectfully requests that the Mayor and the City Councilmembers authorize the City Manager to execute Work Order No. 6 for these services, and

WHEREAS, funds for these services are available in the Capital Improvement Fund, "Capital – Building Account", Account Number 301.80005.500620, encumbered in Purchase Order No. 2021-1359.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:

Section 3. Authorization. The City Manager is authorized to issue Work Order No. 6 to A&P Consulting Transportation Engineers Corp (APCTE) and expend budgeted funds on behalf of the City in furtherance hereof.
