A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA RATIFYING TUESDAY, SEPTEMBER 4, 2012 AT 6:00 P.M. AS THE NEW DATE FOR THE CITY OF DORAL FIRST BUDGET HEARING FOR FY 12-13 AND; WEDNESDAY, SEPTEMBER 19, 2012 AT 5:01 P.M. AS THE NEW DATE FOR THE CITY OF DORAL SECOND BUDGET HEARING FOR FY 12-13; AMENDING RESOLUTION NO. 12-93 TO REFLECT THE NEW HEARING DATES; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, on July 11, 2012, the City Council adopted Resolution No. 12-93 which established a proposed millage rate for FY 12-13 and established the Budget Hearing dates for FY 12-13; and

WHEREAS, the dates for the First and Second Budget Hearings for the City of Doral for FY 12-13 were originally established as Wednesday, September 5, 2012 and Wednesday, September 26, 2012; and

WHEREAS, due to a conflict with the Miami-Dade County School Board Budget Hearing calendar and a conflict with the maximum number of days allotted between the adoption of the tentative budget and the adoption of the final budget, the City requires changing the dates of its First and Second Budget Hearings for FY 12-13, so as to avoid said conflicts and in keeping with State Laws; and

WHEREAS, Staff respectfully requests that the City Council ratify Tuesday, September 4, 2012 at 6:00 p.m. as the new date for the City of Doral First Budget Hearing for FY 12-13 and; Wednesday, September 19, 2012 at 5:01 p.m. as the new date for the City of Doral Second Budget Hearing for FY 12-13; and

**WHEREAS,** Staff further requests that the City Council amend Resolution No. 12-93 to reflect the new hearing dates.
