The scope includes survey and design plans for the median improvements to include left turn lanes along NW 112 Avenue as described in their proposal dated October 21, 2019. The work should be performed in accordance with the contract provisions contained in the Continuing Professional Services Final Agreement between F.R. Aleman and Associates, Inc. and the City of Doral dated February 26, 2018, and the attached Proposal dated January 2, 2019 and submitted by your firm for the above referenced project.

**SCOPE OF SERVICES AND SCHEDULE:**

The scope of the project will be as described in the attached proposal from F.R. Aleman and Associates, Inc. for the design of median improvements along NW 112 Avenue between NW 82 Street and NW 84 Street. The performance of services associated with this Work Order will be executed on a time and material basis not to exceed the amount of \$13,517.00.

You are required by the Continuing Service Agreement to begin work subsequent to the execution of this Work Order, or as directed otherwise. If you fail to begin work subsequent to the execution of this Work Order, the City of Doral will be entitled to disqualify the Proposal, and revoke the award.

This Work Order incorporates the terms and conditions set forth in the Continuing Services Agreement dated February 26, 2018 between the parties as though fully set forth herein. In the event that any terms or conditions of this Work Order conflict with the Continuing Services Agreement, the provisions of this specific Work Order shall prevail and apply.

Work Order is not binding until the City of Doral agrees and approves this Work Order.

F.R. Aleman and Associates, Inc (FRA) proposes to provide the services identified below for the project entitled NW 112 Ave. between NW 112 Ave. to NW 84 St.

#### I. GENERAL

Pursuant to the Scope of Work of the Professional Service Agreement, FRA shall provide professional services in support of the City's Department of Public Works for the above-mentioned project. This includes but is not limited to any coordination between governing agencies, FRA will design construction marking plans for NW 112 Ave. between NW 112 Ave. to NW 84 St. and obtain permit from the Miami Dade County. FRA shall also serve as liaison with Miami-Dade County to assist the City to meet all requirements. Both services shall be accomplished within the following tasks:

#### II. SCOPE OF WORK

- A. *Task 1 – Produce Roadway and Signing and Pavement markings Plans between the limits of the project.*
  - a. *Plans will be produced at 40 scale and will include the following: Key sheet, Summary of Pay Items/Tabulation of Quantities, General Notes, Typical Section and details (1), Roadway Plan (1), Signing and Pavement Plans (1), and Special Detail (As needed).*
  - b. *Implementation of comments to final acceptance.*
  
- B. *Task 2 – Produce tabulation of quantities using latest FDOT Basic of Estimates Pay Items for Signing and Pavement Markings.*
  - a. *Final Surface Pavement markings (Pay Item 710-90 1 LS) will include an Engineer's Cost Estimate using two (2) applications.*

FRA will provide the City with the Services defined by Task 1 - Task 2, above. The anticipated Notice to Proceed for these Services is: October 21, 2019. As requested, the proposal is for a duration time of 180 Calendar Days.




