

**RESOLUTION No. 14-48**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA APPROVING AN OUTDOOR EVENT PERMIT FOR RENAISSANCE CHARTER SCHOOLS, TO HOST THE “INTERNATIONAL FOOD FESTIVAL” EVENT AT 10651 NW 21<sup>ST</sup> STREET, DORAL, ON SATURDAY, MAY 3<sup>RD</sup>, 2014 FROM 1:00 PM TO 5:00 PM ; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, Renaissance Charter Schools (“Applicant”) seeks approval from the City of Doral for an Outdoor Event Permit; and

**WHEREAS**, Staff respectfully recommends that Council approve the proposed Outdoor Event Permit for the Applicant to host the “International Food Festival” event on Saturday, May 3, 2014, from 1:00 pm to 5:00 pm at 10651 NW 21<sup>st</sup> Street, Doral, Florida

**NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:**

**Section 1. Recitals.** The above recitals are true and correct and incorporated herein.

**Section 2. Approval.** The outdoor event permit for “International Food Festival” event is hereby approved subject to the following conditions:

1. That the applicant provide an approval letter from the property owner for the use of the vacant parcel with Folio No. 35-3032-022-0035 which, is located immediately east of Renaissance Charter School (10651 NW 21 Street) prior to the issuance of any building permit.

2. Construction plans for tents and any outdoor structural facility must be submitted to the Building Department at least 2 weeks prior to the event for approval and final inspection.
3. An agreement with the City of Doral Police must be established for off-duty police officers at least 1 week prior to the event (Please refer to the attached action plan fee schedule).
4. Certificate of Liability naming the City additionally insured must be submitted at least 1 week prior to the event.

**Section 3. Effective Date.** This Resolution shall take effect immediately upon adoption.

The foregoing resolution was offered by Vice Mayor Fraga who moved its adoption. The motion was seconded by Councilmember Rodriguez Aguilera and upon being put to a vote, the vote was as follows:
