

RESOLUTION No. 19-40

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, PURSUANT TO SECTION 2-322 OF THE CITY CODE OF ORDINANCES, APPROVING THE PURCHASE AND RETROFITTING OF FIVE (5) NEW POLICE VEHICLES IN AN AMOUNT NOT TO EXCEED \$111,190.00 VIA THE AGREEMENT WITH THE FLORIDA SHERIFF'S ASSOCIATION CONTRACT NO. FSA18-VEL 26.0 WITH AUTONATION CDJR PEMBROKE PINES AND DUVAL FORD FLEET SALES; AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND ENTER INTO AN AGREEMENT, SUBJECT TO APPROVAL AS TO FORM AND LEGAL SUFFICIENCY BY THE CITY ATTORNEY, FOR THE PURCHASE; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the Police Department for the City of Doral (the "City") seeks to purchase five (5) new police vehicles from AutoNation CDJR Pembroke Pines and Duval Ford Fleet Sales via Florida Sheriffs Association Contract #FSA18-VEL 26.0; and

WHEREAS, keeping with the past replacement strategy goals, the City of Doral Police Department recommends the purchase of five (5) new police vehicles to replace one (1) 2008 Ford Expedition, one (1) 2006 Ford Explorer, one (1) 2014 Ford Escape and two (2) 2014 Chevy Tahoes with high mileage and excessive wear. Said vehicles will be turned over to the Public Works, Fleet Maintenance Supervisor, Martin Cevallos for possible reassignment and/or auction; and

WHEREAS, section 2-322 of the City Code of Ordinances authorizes the City to purchase good and services via the contracts of other governmental entities, provided that such contracts have been achieved in a competitive manner similar to those established in the City Code; and

WHEREAS, Staff recommends that the City Council authorize the City

Manager to negotiate and enter into an agreement with AutoNation CDJR Pembroke Pines and Duval Ford Fleet Sales via Florida Sheriff's Association Contract No. FSA18-VEL 26.0 for the purchase of five (5) new police vehicles in an amount not to exceed \$111,190.00, which was competitively entered into in a matter similar to that set forth in Chapter 2, Article V of the City Code; and

NOW, THEREFORE BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:

Section 1. Recitals. The foregoing recitals are confirmed, adopted, and incorporated herein and made part hereof by this reference.

Section 2. Approval. Pursuant to section 2-322, the purchase of five (5) new police vehicles from AutoNation CDJR Pembroke Pines and Duval Ford Fleet Sales via Florida Sheriff's Association Contract No. FSA18-VEL 26.0 in an amount not to exceed \$111,190.00 is hereby approved. This purchase is funded from the Capital Outlay- Vehicles account no. 001.60005.500641.

Section 3. Authorization. The City Manager is hereby authorized to enter into an agreement and other contractual documents, subject to approval as to form and legal sufficiency by the City Attorney, as may be necessary to procure the Vehicles under the Florida Sheriff's Association contract with AutoNation CDJR Pembroke Pines and Duval Ford Fleet Sales to expend funds in furtherance thereof in amounts not to exceed \$111,190.00.

Section 4. Implementation. The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the

purpose and the provisions of this Resolution.

Section 5. Effective Date. This Resolution shall take effect immediately upon adoption.

The foregoing Resolution was offered by Vice Mayor Mariaca who moved its adoption.
