

**RESOLUTION No. 17-83**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING THE TRANSFER OF FUNDS FROM ACCOUNT 001.90005.500340 (CONTRACTUAL SERVICES – OTHER) IN THE AMOUNT OF \$49,200.00 TO ACCOUNT 001.90005.500310 (PROFESSIONAL SERVICES) FOR THE PURPOSE OF ADMINISTERING AND DELIVERING THE SPECIAL NEEDS SURVEY; AUTHORIZING THE CITY MANAGER TO EXECUTE THE TRANSFER NECESSARY TO ACCOMPLISH THE PROJECT; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, on November 2<sup>nd</sup>, 2016, the City Council for the City of Doral (the “City”) approved the quote for Ron Vine and Associates in the amount of \$49,200.00 for the administering of the Special Needs Survey; and

**WHEREAS**, the City would use the data from the survey as a guide for recreational and educational opportunities for our Special Needs Population; and

**WHEREAS**, the City and Ron Vine and Associates entered into an agreement to for the services of administering the Special Needs Survey; and

**WHEREAS**, staff has recommended the Mayor and City Council approval for the transfer of funds from account 001.90005.500340 (Contractual Services – Other) in the amount of \$49,200.00 to account 001.90005.500310 (Professional Services) in order to complete this project.

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:**

**Section 1. Recitals.** The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

**Section 2. Approval of Agreement.** The City Council hereby approves the transfer of funds from account 001.90005.500340 (Contractual Services – Other) in the

amount of \$49,200.00 to account 001.90005.500310 (Professional Services) in order to be able to complete this project and to satisfy the agreement between Ron Vine and Associates and the City of Doral.

**Section 3. Implementation.** The City Manager and the City Attorney are hereby authorized to take such action as may be necessary to implement the provisions of this Resolution.

**Section 4. Effective Date.** This resolution shall take effect immediately upon adoption.
