A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA AUTHORIZING THE CITY MANAGER TO ACCEPT \$200,000 RECEIVED THROUGH THE FLORIDA RECREATION DEVELOPMENT ASSISTANCE PROGRAM GRANT AND APPLY MATCHING FUNDS AS PER THE GRANT AGREEMENT FOR THE DESIGN AND CONSTRUCTION OF MIAMI WEST PARK; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral seeks to improve Miami West Park for the benefit of its residents; and

WHEREAS, the City of Doral Parks and Recreation Department applied for, and has been awarded, a Florida Recreation Development Assistance Program Grant (FRDAP Grant) in the amount of \$200,000 for the design and construction of Miami West Park; and

WHEREAS, in order to receive the grant, the City of Doral must apply matching funds equal to fifty percent (50%) of the total grant in a cash, in-kind, and / or land value type of match; and

WHEREAS, Staff respectfully requests that Council authorize the City Manager to accept the \$200,000 granted to the City of Doral through the FRDAP Grant and apply the matching funds as per the grant agreement (Exhibit 1) for the design and construction of Miami West Park.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL
OF THE CITY OF DORAL, FLORIDA THAT:

<u>Section 1</u>. The foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a part of this Resolution upon adoption hereof.

Section 2. The City Council authorizes the City Manager to accept the \$200,000 granted to the City of Doral through the FRDAP Grant and apply the matching funds as per the grant agreement (Exhibit 1) for the design and construction of Miami West Park.

<u>Section 3</u>. This Resolution shall become effective upon its passage and adoption by the City Council.
