

**RESOLUTION NO. 10- 150**

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, STRONGLY ENCOURAGING THAT ALL FUTURE CITY COUNCILMEMBERS PARTICIPATE IN THE INSTITUTE FOR ELECTED MUNICIPAL OFFICIALS' TRAINING PROGRAM; AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, the Florida League of Cities and the John Scott Dailey Florida Institute of Government have developed the Institute for Elected Municipal Officials ("IEMO"), whose primary objective is to provide elected municipal officials with an intensive academic program that will assist them in effectively meeting the requirements of their elected role; and

**WHEREAS**, IEMO is a three day program that offers a comprehensive overview of Florida municipal government, presented by a faculty of top professionals in the field. The IEMO program, which began in 1992, has graduated more than 1,700 municipal officials; and

**WHEREAS**, the City Council, recognizing that new Council members will be elected in the City Doral (the "City") for the first time in the City's history, believes that participation in the IEMO program would be an effective tool to prepare these new Council members for their important role;

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA AS FOLLOWS:**

**Section 1.** The above and foregoing recitals are true and correct.

**Section 2.** The City Council hereby strongly encourages all future members of the City Council of the City of Doral to participate in the three day program offered

by the Institute for Elected Municipal Officials, and hereby authorizes the City Manager to reimburse such new Council members for the reasonable costs associated with registering for and participating in the three day seminar.

**Section 3.** This Resolution shall take effect immediately upon approval.
