A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING A BUDGET TRANSFER IN THE AMOUNT OF \$57,425.00 FROM ACCOUNT No. 001.50005.500240 TO ACCOUNT No. 001.50005.500450, AND IN THE AMOUNT OF \$121,312.75 FROM ACCOUNT No. 001.50005.500492 TO ACCOUNT No. 001.50005.500450; FOR THE FINAL INSTALLMENT PAYMENT TO THE FLORIDA LEAGUE OF CITIES FOR LIABILITY AND WORKERS COMPENSATION INSURANCE COVERAGE; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral on September 9th,2020 adopted a contract with Halifax-Acentria Public Risk, in partnership with the Florida Municipal Insurance Trust (FMIT) to provide Insurance and Risk Management for the City.

WHEREAS, the city's quarterly premium payment for insurance for General Liability, Automobile, Property damage and Workers Compensation is \$345,111.75; and

WHEREAS, the costs this year for the referenced insurance coverages exceeded the amount forecasted in the budget by \$240,063.75; and

WHEREAS, The City Attorney's office is requesting for a one-time transfer from Workers Compensation Account (001.50005.500240) in the amount of \$57,425.00 to Insurance Account (001.50005.500450); and

WHEREAS, in addition, we are also requesting a one-time transfer from Contingent Reserve Account (001.50005.500492) in the amount of \$121,312.75 to the Insurance Account (001.50005.500450) to complete the pending balance; and

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:
