Pillsbury Lures DOJ Lawyer Who Thwarted Trump Putsch

Adding to its growing roster of attorneys with government experience, Pillsbury Winthrop Shaw Pittman has tapped a longtime prosecutor and former Department of Justice lawyer who reportedly helped thwart former President Donald Trump's attempts to overturn the 2020 U.S. presidential election.

Richard Donoghue, who served as acting U.S. deputy attorney general at the Department of Justice during the final months of the Trump administration, Monday joined Pillsbury's corporate investigations and whitecollar defense practice as a partner in the firm's New York office.

According to a recently released Senate report, Donoghue, a Republican, earlier this year resisted pressure from Trump to use Justice Department resources and personnel to investigate debunked election fraud allegations. Donoghue was also present with then-acting attorney general Jeffrey Rosen at a Jan. 3 White House meeting where Trump proposed sacking the U.S. attorney in Atlanta, Byung Pak, who had refused to falsely assert the Justice department had found irregularities in Georgia voting. At that meeting, Donoghue reportedly counseled Trump not to fire Pak, and warned the president that attempting to use the Justice Department to pursue false election claims would result in mass resignations.

Donoghue is a seasoned prosecutor and a former U.S. attorney for the Eastern District of New York from January 2018 to July 2020. He has several high-profile convictions under his belt; while serving as the Brooklyn prosecutor, he successfully prosecuted Mexican drug lord Joaquin "El Chapo" Guzman.

In a statement announcing his recruitment to the firm, Deborah Baum, the leader of the Pillsbury's global litigation section, said Donoghue's "experience spans prominent government positions, senior in-house roles and a lengthy list of high-profile trial wins and successful government investigations, so he can leverage special value for our clients, adding perspective from every angle."

Donoghue started his legal career in the Judge Advocate General's Corps for the U.S. Army, where he held several roles, including Military Magistrate Judge. He then moved to the DOJ where he spent 11 years, eventually rising to chief of the criminal division. Afterward, he spent six years as in-house counsel at software firm CA Technologies.

When Donoghue was at CA Technologies, he was a client of Pillsbury.

"I saw how serious and talented their lawyers were and felt if I ever went to a firm, they were a good fit for me," he said.

Throughout his career, Donoghue has worked in several litigation practice ar-

eas both domestically and internationally—military law, intellectual property, criminal, white-collar, regulatory investigations and corporate litigation—and he said the practice he intends to develop will lean on his various skills and experiences to help clients mitigate the risk of trial, or to succeed at trial.

"You're going to see increased scrutiny from regulators as we emerge from COVID, and you're going to see a continuing and expanded interest in allegations of corporate misconduct, so to the extent I can help clients out with those things I'll be happy to do it," said Donoghue, who sees both his in-house corporate and government experience as an advantage for potential clients. "It provides me both with an understanding of what clients need and the situations they may face from government agencies."

Pillsbury has increasingly become the home of choice to many lawyers with top government experience. This year alone, the firm has recruited California Gov. Gavin Newsom's former deputy legal affairs secretary Daniel Bromberg, ex-federal prosecutor Kimberly Jaimez, retired Judge James Catterson, and former associate deputy attorney general Patrick Hovakimian.

Another Trump-appointed lawyer who ultimately resisted efforts to overturn the 2020 election has recently landed in private practice. Former White House Counsel Pat Cipollone last week opened a D.C. office for California firm Browne George Ross; with Cipollone's arrival, the firm will be renamed Ellis George Cipollone. Cipollone was reportedly present in January 2021 when in a White House meeting Trump apparently contemplated replacing Rosen with a loyalist who, unlike Rosen, was open to pushing the Department of Justice into pursuing claims of election fraud in the November 2020 elections. By the accounts of one official at the time, "Pat pretty much saved Rosen's job that day," after objecting strenuously to the idea.


