

RESOLUTION No.19-55

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING THE USE OF THE EXISTING PROFESSIONAL SERVICES AGREEMENT WITH ROBERT HALF INTERNATIONAL, INC., TO FILL THE IT SECURITY MANAGER POSITION VACANCY IN AN AMOUNT NOT TO EXCEED \$19,200.00 IN FURTHERANCE HEREOF; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, In August 8, 2018 the Mayor and City Council approved on Resolution No. 18-115 a Professional Services Agreement(PSA) with Robert Half International, Inc. to provide professional temporary to hire staffing services for a period of one(1) year; and

WHEREAS, due to the specialization of IT Security Manager position and competitive nature currently experienced in this industry, we are looking to use same PSA terms to fill our IT Security Manager Position vacancy; and

WHEREAS, IT Security Manager is a highly trained technologist who is responsible for citywide information security program and ongoing activities to preserve the availability, integrity and confidentiality of the City information resources in compliance with the applicable security policies and standards; and

WHEREAS, The Information Technology department respectfully recommends the use of the existing Professional Services Agreement with Robert Half International, Inc. to fill our IT Security Manager Position vacancy in an amount not to exceed \$19,200. Funding for this request is available in IT Account No. 001.22002.500310.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL

OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

Section 2. Approval. The use of existing Professional Service Agreement with Robert Half International, Inc. to fill our IT Security Manager Position vacancy in an amount not to exceed \$19,200.

Section 3. Authorization. The City Manager is hereby authorized to use existing PSA for the rendition of the Services, and expend budgeted funds, in furtherance hereof.

Section 4. Implementation. The City Manager and City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and provisions of this Resolution.

Section 5. Effective Date. This Resolution shall become effective immediately upon its adoption.
