

**RESOLUTION No. 21-177**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AWARDED REQUEST FOR PROPOSALS #2021-13 "TOWING AND WRECKER SERVICES" TO THE THREE TOP FIRMS, AND AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND ENTER INTO AN AGREEMENT WITH ALPINE TOWING, MAGIC TOWING AND KINGS WRECKER SERVICES FOR THE PROVISION OF TOWING AND WRECKER SERVICES FOR A TWO (2) YEAR PERIOD WITH OPTION TO RENEW FOR THREE (3) ADDITIONAL ONE (1) YEAR PERIODS FOR A TOTAL OF FIVE (5) YEARS; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, the City of Doral (the "City") issued Request for Proposal No. 2021-13 (the "RFP") for Towing and Wrecker Services on May 13, 2021, advertising on the City's Procurement website, on DemandStar, and Vendor Registry; and

**WHEREAS**, as a result of the advertisement, twelve people were in attendance representing eight (8) firms at the Mandatory Pre-bid Meeting held on May 25, 2021 and eight (8) submittals were received and opened on June 16, 2021, with all firms meeting the minimum required criteria; and

**WHEREAS**, the City's evaluation committee held a public meeting on July 9, 2021 (Phase I) where the committee evaluated, scored/ranked the firms. A recommendation was made to award the top three (3) ranked firms: Alpine Towing, Magic Towing and Kings Wrecker Services.

**WHEREAS**, Staff has recommended the City Council approve the results of RFP No. 2021-13 Towing and Wrecker Services for Police Department's towing services and expend budgeted funds for these services.

**NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:**

**Section 1. Recitals.** The foregoing recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

**Section 2. Approval.** The RFP No. 2021-13 hereby awards all firms, Alpine Towing, Magic Towing and Kings Wrecker Services.

**Section 3. Authorization.** The City Manager to enter into agreements with Alpine Towing, Magic Towing and Kings Wrecker Services based on the outcome from the RFP No. 2021-13- Towing and Wrecker Services to the Police Department with appropriate funds for a two (2) year term. Upon completion of the initial term, the City shall have the option to renew the contracts for three (3) additional one (1) year periods for a total of five (5) years.

**Section 4. Implementation.** The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and provisions of this Resolution.

**Section 5. Effective Date.** This Resolution shall take effect immediately upon adoption.

The foregoing Resolution was offered by Councilmember Puig-Corve who moved its adoption. The motion was seconded by Councilmember Mariaca and upon being put to a vote, the vote was as follows:
