

**RESOLUTION No. 19-218**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING A WORK ORDER BETWEEN THE CITY OF DORAL AND PEVIDA HIGHWAY DESIGNERS FOR THE PROVISION OF CONSTRUCTION ENGINEERING INSPECTION (CEI) SERVICES FOR THE CONSTRUCTION OF STORMWATER IMPROVEMENTS AT SUB BASIN A-4, WHICH IS LOCATED ALONG NW 84 AVENUE BETWEEN NW 25 STREET AND NW 12 STREET, IN AN AMOUNT NOT TO EXCEED \$90,860.00; RECOGNIZING THAT PEVIDA HIGHWAY DESIGNERS IS A CITY OF DORAL PRE-QUALIFIED VENDOR; AUTHORIZING THE CITY MANAGER TO EXECUTE THE WORK ORDER AND EXPEND BUDGETED FUNDS ON BEHALF OF THE CITY; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, the City of Doral Public Works Department (PWD) wishes to secure a firm to provide Construction Engineering Inspection (CEI) services for the construction the stormwater improvements at Sub Basin A-4 located along NW 84 Avenue between NW 25 Street and NW 12 Street; and

**WHEREAS**, the PWD requested a proposal from Pevida Highway Designers, for the provision of Construction Engineering Inspection (CEI) services for the Sub Basin A-4 stormwater improvements.; and

**WHEREAS**, Pevida Highway Designers is a pre-qualified provider of professional engineering services selected in accordance with Consultant Competitive Negotiation Act (CCNA) requirements and approved by the City Council in November 2017; and

**WHEREAS**, City staff respectfully requests that the Mayor and City Council members approve Work Order No. 07 for Pevida Highway Designers, a copy of which is attached hereto as Exhibit "A", for the provision of CEI services for the construction of the stormwater improvements at Sub Basin A-4 located along NW 84 Avenue between

NW 25 Street and NW 12 Street on a time and material basis in an amount not to exceed \$90,860.00.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:**

**Section 1. Recitals.** The above recitals are confirmed, adopted, and incorporated herein and made part hereof by this reference.

**Section 2. Approval.** Work Order No. 07 for CEI services during the construction of the stormwater improvements at Sub Basin A-4 located along NW 84 Avenue between NW 25 Street and NW 12 Street, in an amount not to exceed \$90,860.00, a copy of which is attached hereto as Exhibit "A", together with such non-material changes as may be acceptable to the City Manager and approved as to form and legality by the City Attorney, is hereby approved.

**Section 3. Authorization.** The City Manager is authorized to execute the work order and expend budgeted funds on behalf of the City.

**Section 4. Implementation.** The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and the provisions of this Resolution.

**Section 5. Effective Date.** This Resolution shall take effect immediately upon adoption.

The City of Doral authorizes the firm of Pevida Highway Designers, LLC to proceed with the provision of professional engineering services for Construction Engineering & Inspection (CEI) services for Sub Basin A-4 which is located along NW 84 Avenue between NW 12 Street and NW 25 Street as of the date of this work order. The work should be performed in accordance with the contract provisions contained in the Continuing Professional Services Agreement between Pevida Highway Designers, LLC and the City of Doral dated February 16, 2018, and the attached Proposal dated July 30, 2019 and submitted by your firm for the above referenced project.

**SCOPE OF SERVICES AND SCEHDULE:**

The scope of the project will be as described in the attached proposal from Pevida Highway Designers, LLC for the Supplemental Services. The scope of service will include monitoring the installation of the new drainage system, curb and gutter, milling and resurfacing, and pavement markings. The schedule of the work to be provided is two hundred and sixty (260) calendar days from NTP. The performance of services associated with this Work Order will be executed on a time and material basis not to exceed the amount of \$90,860.00.

You are required by the Continuing Service Agreement to begin work subsequent to the execution of this Work Order, or as directed otherwise. If you fail to begin work subsequent to the execution of this Work Order, the City of Doral will be entitled to disqualify the Proposal and revoke the award.

Work Order incorporates the terms and conditions set forth in the Continuing Services Agreement dated February 16, 2018 between the parties as though fully set forth herein. In the event that any terms or conditions of this Work Order conflict with the Continuing Services Agreement, the provisions of this specific Work Order shall prevail and apply. This Work Order is not binding until the City of Doral agrees and approves this Work Order.

IN WITNESS WHEREOF, the parties hereto have executed this Agreement on the day and date first above written, in three (3) counterparts, each of which shall, without proof or accounting for the other counterpart be deemed an original Contract.
