## RESOLUTION No. 15-177

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA SITTING AS THE LOCAL PLANNING AGENCY, GOING FORWARD WITHOUT A RECOMMENDATION TO AMEND THE CITY OF DORAL COMPREHENSIVE PLAN FUTURE LAND USE ELEMENT TEXT FOR THE COMMUNITY MIXED USE (CMU) LAND USE CATEGORY; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Sanctuary at Doral, LLC, ("Applicant"), has requested text amendments to the Comprehensive Plan Future Land Use Element Community Mixed Use Category to reduce the minimum site area from 15 acres to 7 acres, allow retail and commercial service uses in single-use buildings, and provide a 30% housing density bonus for the provision of 20% of total units as workforce housing; and

WHEREAS, on September 16, 2015, the City Council of the City of Doral sitting as the Local Planning Agency (LPA) at a properly advertised hearing received testimony and evidence related to the Application from the Applicant and other persons and found that the text amendment to the Comprehensive Plan Land Use Element Community Mixed Use Category, as recommended by staff, is with the Comprehensive Plan or decided to transmit without a recommendation.
