

**RESOLUTION NO. 12-77**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA WAIVING THE COMPETITIVE BIDDING PROCEDURE PURSUANT TO SECTION 2-321 OF THE CITY CODE; AUTHORIZING THE CITY MANAGER TO PURCHASE SIXTEEN (16) LAPTOP COMPUTERS FROM GOVCONNECTION FOR THE USE OF THE CITY OF DORAL BUILDING DEPARTMENT IN AN AMOUNT NOT TO EXCEED \$32,304.48; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, the City of Doral Building Department's current laptops were purchased during the period of August 2006 and September 2007 and have thus exceeded their life span and repairs are no longer cost effective; and

**WHEREAS**, Staff obtained three (3) quotes from qualified vendors to determine the best possible pricing available for the replacement of the laptop computers; and

**WHEREAS**, Staff respectfully requests that the City Council waive the competitive bidding procedure pursuant to Section 2-321 of the City Code and authorize the City Manager to purchase sixteen (16) laptop computers from GovConnection for the use of the City of Doral Building Department in an amount not exceed \$32,304.48.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:**

**Section 1.** The City Council of the City of Doral hereby waives the competitive bidding procedure pursuant to Section 2-321 of the City Code and authorizes the City Manager to purchase sixteen (16) laptop computers from GovConnection for the use of the City of Doral Building Department in an amount not exceed \$32,304.48.

**Section 2.** This Resolution shall become effective immediately upon adoption.

The foregoing Resolution was offered by Councilmember Boria who moved its adoption. The motion was seconded by Councilmember Rodriguez and upon being put to a vote, the vote was as follows:


