

RESOLUTION No.17-79

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING A WORK ORDER WITH STRUCTURED CABLING SOLUTIONS, INC. FOR THE PROVISION OF WIRING SERVICES FOR THE POLICE SUBSTATION PROJECT, IN AN AMOUNT NOT TO EXCEED \$23,122.15; AUTHORIZING THE CITY MANAGER TO EXECUTE THE WORK ORDER AND TO EXPEND BUDGETED FUNDS; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral (the "City") issued Invitation to Bid #2015-39, "Cabling Services" (the "ITB"), on November 7, 2015 for the purpose of providing data wiring services throughout the City; and

WHEREAS, following competitive bidding and staff recommendation, the City Council approved an agreement with Structured Cabling Solutions ("SCS"); and

WHEREAS, on February 3, 2016, the City entered into an agreement with SCS for a three year agreement with the option to renew the contract for two (2) additional terms to provide Data Wiring Services throughout the City as needed and the scope, with work orders over \$15,000.00 coming back to the City Council for approval; and

WHEREAS, staff has recommended that the City Council approve a work order for SCS for the wiring services for the police department substation in an amount not to exceed \$23,122,15; and

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The foregoing recitals, are adopted, confirmed, and incorporated herein and made a part hereof by this reference.

Section 2. Approval. The Work Order by SCS for the cabling services for the police substation in the amount of \$23,122.15, attached hereto as Exhibit "A", which is incorporated herein and made a part hereof by this reference, is hereby approved.

Section 3. Authorization. The City Manager is hereby authorized to execute the work order and other contractual documents, subject to approval by the City Attorney as to form and legal sufficiency, as may be necessary to consummate the procurement of the good and services contemplated herein. The City Manager is further authorized to expend budgeted funds in furtherance hereof.

Section 4. Implementation. The City Manager and City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and provisions of this Resolution.

Section 5. Effective Date. This Resolution shall take effect immediately upon adoption.

The foregoing Resolution was offered by Councilmember Rodriguez who moved its adoption. The motion was seconded by Councilmember Mariaca and upon being put to a vote, the vote was as follows:
