RESOLUTION NO. 11-151

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, PROVIDING FOR AN AMENDMENT OF THE CITY GENERAL GOVERNMENT BUDGET FOR FISCAL YEAR 2011-2012 FOR THE PURPOSES OF FUNDING THE DORAL DESIGN DISTRICT STREET FAIR; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, branding and stakeholder outreach converge in the concept of a Doral Design District Street Fair on NW 79 Avenue, now known as Tile & Marble Boulevard, featuring art, design, and tastes highlighting the businesses, trades, restaurants and artisans of the City of Doral;

WHEREAS, currently, the City of Doral is renowned for its tile and marble products, design trades, artisanship and restaurants; and

WHEREAS, various City of Doral Committees, including the International Business Development Advisory Committee, Cultural Affairs Committee, and Park and Police for Kids Committee, have discussed the need to highlight these unique offerings; and

WHEREAS, the Doral Design District Steering Committee (DDDSC) has commenced preliminary discussions with the Rotary Club in an effort to bring next year's arts festival to the Tile & Marble Boulevard; and

WHEREAS, the DDDSC has also discussed entertainment, children activities, home renovation simulations from potential sponsors, and involvement from media such as Univision and HGTV at the Street Fair; and

WHEREAS, the DDDSC intends to coordinate with the International Business Development Advisory Committee, Cultural Affairs Committee, and Park and Police for Kids Committee to join resources to establish the first Doral Design District Street Fair (the "Fair"); and

WHEREAS, the appropriation and authorization of funds is necessary for marketing and organizational purposes; and

WHEREAS, the DDDSC respectfully requested that the City Council endorse the establishment of the Fair and allocate \$50,000 to that project; and

WHEREAS, the City Council wishes to appropriate \$50,000 for the establishment of the first Doral Design District Street Fair on N.W. 79th Avenue; and

WHEREAS, the City Council finds it necessary to adjust the City's General Government Budget for Fiscal Year 2011-2012 (the "Budget") in order to reflect the \$50,000 expense for the street fair; and

WHEREAS, under State law, when appropriations for expenditures are being moved from one line item to another line item within the same fund budget without any change in the total appropriations of such fund, such actions may be approved by resolution of the City Council;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:

Section 1. Recitals. The foregoing recitals are hereby ratified and confirmed as being true and correct and hereby made a specific part of this Resolution upon adoption hereof.

Section 2. <u>Budget Amendment</u>. In accordance with Section 166.241(4)(a), Florida Statutes, the General Government Budget is hereby amended by the appropriation to the following line item budget: General Government: Other Charges and Obligations - Account 001.50005.500490: \$50,000. An appropriation is being made from the General Government: Contingent Reserve Fund — Account 001.50005.500492. These funds are being re-allocated and dedicated for the first Doral Design District Street Fair.

Section 3. <u>Effective Date</u>. This Ordinance shall become effective immediately upon adoption.
