## **RESOLUTION No. 17-62**

WHEREAS, the Race Time, LLC ("Applicant") seeks approval from the City of Doral for an Outdoor Event Permit, pursuant to the application attached hereto as Exhibit "A"; and

- 3. Compliance with the comments set forth by the Parks and Recreation Department, as specified in Exhibit "C"; and
- 4. The payment of all fees specified in Exhibit "D".
