A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND ENTER INTO AN AGREEMENT WITH T&G CONSTRUCTION, LEGO CONSTRUCTION AND STATE CONTRACTING & ENGINEERING FOR THE PROVISION OF PROVIDING MINOR REPAIRS, ALTERATIONS AND REMODELING OF CITY FACILITIES; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in response to RFQ #2014-13 titled "City Hall Minor Repairs, Alterations, and Remodeling" (the "Project"), the City of Doral received twelve (12) submittals by the April 30, 2014 deadline with all twelve (12) companies meeting the required criteria; and

WHEREAS, upon review of bids received, Staff determined that T&G Construction, Lego Construction, and State Contracting & Engineering were the lowest most responsive and responsible bidders (the "Contractors"); and

WHEREAS, a copy of RFQ #2014-13, Pre-Bid sign-in sheet, and the Evaluation Score Sheet Submittal are attached as Exhibit A; and

WHEREAS, the City Council finds that accepting the bid and entering into a contract for the Project with the Contractors is in the best interest of the City.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:

Section 1. Recitals. The above recitals are true and correct and incorporated herein.

Section 2. Approval. Authorization for the City Manager to negotiate and enter into an agreement with: T & G Construction, Lego Construction and State Contracting & Engineering to provide Minor Repairs, Alterations and Remodeling of City Facilities for an initial contract term of two (2) years with an option to renew for one (1) additional year, a copy of which is attached hereto as Exhibit "A" together with such non-material changes as may be acceptable to the City Manager and approved as to form and legality by the City Attorney, is hereby approved. The City Manager is authorized to negotiate and enter into an agreement with: T & G Construction, Lego Construction and State Contracting & Engineering to provide Minor Repairs, Alterations and Remodeling of City Facilities.

<u>Section 3.</u> <u>Effective Date.</u> This Resolution shall take effect immediately upon adoption.
