

**RESOLUTION NO. 12-84**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA AUTHORIZING AN EXTENSION TO THE EXISTING AGREEMENT WITH BLUEWAVE COMMUNICATIONS FOR THE PROVISION OF ADDITIONAL NETWORK BACKBONE AND WIRING FOR THE NEW CITY HALL AND PARKING GARAGE IN THE AMOUNT OF \$14,900.00 FOR A TOTAL NOT TO EXCEED AMOUNT OF \$104,750.00; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, in response to RFP #2012-01 titled “Network Backbone and Wiring for New City Hall,” the City Council awarded a contract to Bluewave Communications (Bluewave) in an amount not to exceed \$89,850.00; and

**WHEREAS**, Staff has identified additional work that is needed for the full implementation of the backbone which was not included in the original scope of work and have received a cost estimate from Bluewave for this work in the amount of \$14,900.00; and

**WHEREAS**, Staff respectfully requests that the City Council authorize an extension of the existing agreement with Bluewave for the provision of additional network backbone and wiring for the new City Hall and parking garage in the amount of \$14,900.00 for a total not to exceed amount of \$104,750.00.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:**

**Section 1.** The City Council of the City of Doral hereby authorizes an extension of the existing agreement with Bluewave for the provision of additional network backbone and wiring for the new City Hall and parking garage in the amount of \$14,900.00 for a total not to exceed amount of \$104,750.00.

**Section 2.** This Resolution shall become effective immediately upon adoption.
