A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AWARDING REQUEST FOR PROPOSALS #2019-19 "COMPETITIVE AND TRAVEL YOUTH BASEBALL PROGRAM MANAGEMENT" TO DORAL LITTLE LEAGUE FOR THE PROVISION OF COMPETITIVE AND TRAVEL YOUTH BASEBALL PROGRAMMING; AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND ENTER INTO AN AGREEMENT WITH DORAL LITTLE LEAGUE FOR A PERIOD OF ONE (1) YEAR; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, On April 11, 2019, the City of Doral (the "City") advertised Request for Proposals ("RFP") # 2019-19 "Competitive and Travel Youth Baseball Program Management" for the provision of providing competitive and travel youth baseball programming for the Parks & Recreation Department; and

WHEREAS, Four (4) firms attended the mandatory pre-bid meeting on April 22, 2019. One (1) submittal was received and opened on May 8, 2019, with that firm meeting the required criteria set forth in the RFP; and

WHEREAS, On June 6, 2019, the evaluation committee scored and ranked the submittal based on a three-hundred point (300) scale. The firm was invited to participate in phase II of the evaluation, which was held on July 11, 2019 and the evaluation committee met to re-evaluate. The ranking of firms is as follows...

WHEREAS, staff respectfully requests approval to award RFP #2019-19 ""Competitive and Travel Youth Baseball Program Management" to the top ranked firm and authorize the City Manager to negotiate and enter into an agreement with Doral Little

League for the provision of providing competitive and travel youth baseball for a period of one (1) year.

NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

<u>Section 1.</u> The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

Section 2. Approval & Authorization. The City Council hereby approves the award of RFP # 2019-19 to the top ranked firm and authorizes the City Manager to negotiate and enter into an agreement with Doral Little League for the provision of providing competitive and travel youth baseball programming for a period of one (1) year.

The agreement is subject to approval by the City Attorney as to form and legal sufficiency and on such other terms and conditions as may be appropriate to protect and further the interest of the City. This Authorization does not create or confer any rights to Doral Little League.

Section 3. Implementation. The City Manager and the City Attorney are hereby authorized to take such action as may be necessary to implement the provisions of this Resolution.

<u>Section 4.</u> <u>Effective Date.</u> This resolution shall take effect immediately upon adoption.
