5. Approval of Minutes

June 8, 2021

Motion to approve made by Secretary Flynn and seconded by Member Juarez. By consensus, minutes were approved.

6. Discussion Items

a. Discussion: Recap of items proposed to Council
Primary new initiative is to hold family day in December. Concern whether new variant
of Covid will settle to be able to hold public event. Board consensus will be to continue
ahead, planning for family day to be held and be prepared to cancel if risk is deemed
high closer to the time of the event.

Event planned to be held at Doral Glades Park on Saturday, December 11, 2021. Board Members will present this plan to the City Council at the next Council meeting on August 11, 2021, 10:00 a.m. At the very least, Board Chair Bill Watts will be present, additional board members plan to be present.

Initial intent on family day would be to sponsor specific local unit, as done in past years. Discussion and general board consensus now to turn this into local veteran event, set Event Bright to specific number of signups. Member Bautista motioned to change the family day from unit sponsored event to a veteran sponsored event. Member Juarez seconded. All approved, motion carried.

Additional co-events to invite: local Marine contingent to sponsor annual Toys for Tots, hold possible blood drive, Covid vaccination drive, and donated food items/food drive. Secretary Flynn will reach out to City of Doral Public Affairs about advertising this event, once approved by City Council. Initial advertising intended to reach out to local Doral veterans, wait a couple weeks to see how many respond; potentially open to veterans across Miami if larger response rate needed, advertise through VA and local veteran groups.

Family day event items to bring before the Council on August 11:

- Waiver of park fees, Doral Glades Park
- Off-duty police officer
- · Website social media to advertise/sponsor event
- Event Bright Council, City office, or Board to set advertisement
- Request Mayor and/or Council Members to appear on event day
- Reach out to Parks Department for tents, tables, chairs, and park capacity
- Fund raising events in the name of Board for veteran event
- City funds that may be needed in addition to fund raising
- Additional co-events: Toys for Tots, blood drive, Covid drive, food drive

b. Open Discussion

Member Bautista brought to the table SouthCom interest in housing in Doral for assigned military members. Past discussions have covered stipends, rental agreements, down payments and security deposits that many junior military members cannot afford. Noted plans are in place to put military housing in Doral. Board is interested in continuing this discussion but not at this time. Intent is to press forward quickly with family day planning and bring this discussion back to the table as planning time permits.

7. Discussion of next meeting agenda items

Discussion will continue moving forward with family day event. Discussion will include outcome of August 11 City Council Meeting. Housing in Doral discussion will continue as time on family day planning permits.

8. Future Meeting Date

As the Board will present family day items to the City Council on August 11, the Board will meet at the soonest available date to discuss Council approval of items and next steps the Board needs to take to press this initiative into action. Secretary Flynn motioned to hold the next meeting on Monday, August 16, at 6:00 p.m., to cover any issues that arise from the City Council meeting. Vice Chair Prather seconded. All approved, motion carried.

September 7, 2021 meeting date will be kept as a regular meeting to continue discussing event momentum.

Future meetings may be deemed necessarily to continue forward momentum of family day event planning, intent to keep current set dates with inclusion of additional dates as needed.
