A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA ESTABLISHING A PROPOSED MILLAGE RATE OF 2.447 TO BALANCE THE GENERAL FUND FOR FISCAL YEAR 2010-2011; ESTABLISHING THE CURRENT ROLLED-BACK RATE TO BE 2.63833 ESTABLISHING THE FIRST AND SECOND PUBLIC BUDGET HEARINGS AS REQUIRED BY LAW: DIRECTING THE CLERK AND MANAGER TO FILE SAID RESOLUTION WITH THE PROPERTY APPRAISER OF MIAMI-DADE COUNTY PURSUANT TO THE REQUIREMENTS OF FLORIDA STATUTES AND THE RULES AND REGULATIONS OF THE DEPARTMENT OF REVENUE AND THE STATE OF FLORIDA; ESTABLISHING THE TIME AND LOCATION OF THE FIRST AND SECOND PUBLIC HEARINGS: AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, on July 1, 2010, the Honorable Pedro J. Garcia, Jr., Miami-Dade County Property Appraiser, served upon the City of Doral a "Certification of Taxable Value" certifying to the City of Doral its 2009 taxable value; and

WHEREAS, the provisions of Florida Statues Section 200.065 require that within thirty five (35) days of service of the Certification of Taxable Value upon a municipality, said municipality shall be required to furnish to the Property Appraiser of Miami-Dade County the proposed millage rate, the current year roll back rate, and the date, time and place at which a first public hearing will be held to consider the proposed millage rate and tentative budget; and

WHEREAS, The City Council desires to announce the dates of the first and second hearings to the Property Appraiser of Miami-Dade County; and

WHEREAS, The City Council has reviewed the figures supplied by the Property Appraiser of Miami-Dade County and that being otherwise fully advised in the premises;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA AS FOLLOWS:

<u>Section 1</u>. That the proposed millage for the first public hearing is hereby declared to be 2.447 mills which is 2.447 per \$1,000.00 of assessed property within the City of Doral.

<u>Section 2.</u> That the City Council further confirms the current year rolled back rate computed pursuant to section 200.065 F.S., is 2.63833 mills which is 2.63833 per \$1,000.00 of assessed property within the City of Doral.

<u>Section 3.</u> That the date, time and place of the first and second public hearings are hereby set by the City Council as follows:
