## **RESOLUTION No. 16-02**

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, PURSUANT TO SECTION 2-322 OF THE CITY CODE OF ORDINANCES, APPROVING THE PURCHASE OF ONE 2016 FORD F-150 (REGULAR CAB) VEHICLE, INCLUDING LED CORNER STROBES AND A BACK-UP ALARM FOR THE CODE COMPLIANCE DEPARTMENT IN AMOUNT NOT TO EXCEED \$19,761.00, VIA STATE OF FLORIDA CONTRACT # 15-23-0904; AUTHORIZING THE CITY MANAGER TO EXECUTE CONTRACTUAL DOCUMENTS AND TO EXPEND BUDGETED FUNDS IN FURTHERANCE HEREOF; PROVIDING FOR IMPLEMENTATION; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the Code Compliance Department for the City of Doral (the "City") has a need to purchase an additional vehicle to replace a current depreciated vehicle in its fleet and to provide a pick-up truck that the Department personnel can use for expanded enforcement responsibilities during the course of their duties; and

WHEREAS, Section 2-322 of the City Code provides that the City may enter into entered into by other governmental authorities provided that the governmental authority has followed a competitive bidding procedure leading to the award of the bid or contract in question which is substantially similar to the competitive bidding procedure outlined in this article; and

WHEREAS, the State of Florida competitively bid, in a manner similar to that set forth in Article V of the City Code, the provision of fleet vehicles and awarded an agreement to Don Reid Ford, Inc., a copy of which is attached as Exhibit "A" ("State Contract"); and

WHEREAS, Staff has reviewed and analyzed the State Contract and finds the provision of fleet vehicles and the corresponding prices to be highly competitive and advantageous to the City and recommends the City procure one (1) 2016 Ford F-150

(Regular Cab) vehicle, including corner LED strobe lights and a back-up alarm (the "Vehicle") pursuant to the State Contract; and

WHEREAS, the purchase of the Vehicle will provide the Code Compliance Department with savings in its budget by replacing a current vehicle in its fleet that is in constant need of repairs which will result in reduced down time and better overall service to the Doral community; and

**WHEREAS**, the Code Compliance Department had previously budgeted for the purchase of one vehicle.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL
OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

**Section 1.** Recitals. The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

Section 2. Procurement Approved. Pursuant to Section 2-322 of the City Code, the procurement of one (1) Ford F-150 (Regular Cab) vehicle, including corner LED strobe lights and a back-up alarm, for the Code Compliance Department from Don Reid Ford, Inc. in a purchase price amount not to exceed \$19,761.00, via the State Contract, a copy of which is attached hereto as Exhibit "A" and incorporated herein by this reference, is hereby approved.

<u>Section 3.</u> <u>Authorization.</u> The City Manager is hereby authorized to execute any purchase orders, agreements or other documents, after approval as to form and legal sufficiency by the City Attorney, as may be needed to accomplish the contemplated purchase of the Vehicle and to expend budgeted funds on behalf of the City with respect to the purchase approved herein.

<u>Section 4.</u> <u>Implementation.</u> The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and provisions of this Resolution.

<u>Section 5.</u> <u>Effective Date.</u> This Resolution shall take effect immediately upon adoption.
