A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AUTHORIZING THE TROLLEY SERVICE EXTENSION OF ROUTE 2 OF THE DORAL TROLLEY SYSTEM (DTS) IN ORDER TO PROVIDE SERVICE TO THE VANDERBILT PARK AREA, DORAL ACADEMY CHARTER ELEMENTARY SCHOOL, AND JACKSON MEMORIAL HOSPITAL DORAL WEST CAMPUS; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral Public Works Department (PWD) continuously reviews the Doral Transit System (DTS) operation to recommend improvements that will allow the City to keep up with passenger demands; and

WHEREAS, received a request to provide transit service to the Vanderbilt Park

area which is not currently service by DTS; and

WHEREAS, Jackson Memorial Hospital Doral West Campus will be opening on

August 2021; and

WHEREAS, Doral Trolley Route 2 currently services Palmetto Metrorail Station, a main interconnectivity location, which will benefit the Hospital staff coming into the City by providing an alternative method of transportation, and consequently reducing traffic congestion by removing vehicles off the City roads; and

WHEREAS, the PWD recommends expanding Trolley Route 2 to service the Vanderbilt Park area, Doral Academy Charter Elementary School, and the Jackson Memorial Hospital Doral West Campus area; and

WHEREAS, funding for this request is available in the current Fiscal Year in the Public Works Department Transportation Fund, Account No. 101.80005.500341, "Contractual Services – Engineer", and in the Public Works Department People's Transportation Fund (CITT Fund), Account No. 106.80005.500341, "Contractual

Services – Engineer", encumbered in PO Num. 2021-0565.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:

Section 1. Recitals. The above recitals are confirmed, adopted, and incorporated herein and made part hereof by this reference.

<u>Section 2.</u> <u>Approval</u>. The City Council Hereby Approves the Trolley service extension of Route 2 of the Doral Trolley System (DTS) in order to provide service to the Vanderbilt Park area, Doral Academy Charter Elementary School, and Jackson Memorial Hospital Doral West Campus.

Section 3. Authorization. The City Manager is authorized to extend the Doral Trolley Route 2 service and expend funds on behalf of the City in furtherance hereof.

<u>Section 4.</u> <u>Implementation</u>. The City Manager and City Attorney are hereby authorized to take such action as may be necessary to implement the purpose and the provisions of this resolution.

Section 5. Effective Date. This Resolution shall take effect immediately upon adoption.
