

RESOLUTION No. 19-158

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING AMENDMENTS TO THE EMPLOYMENT AGREEMENT WITH LUIS FIGUEREDO AS CITY ATTORNEY; PROVIDING FOR AUTHORIZATION; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, on August 22, 2018, Mr. Luis Figueredo was nominated and approved for the position of City Attorney; and

WHEREAS, during this time, a mutual agreement was reached, and terms were negotiated with Mr. Figueredo and the City; and

WHEREAS, on May 8, 2019, upon the approval of the current City Manager's Employment Agreement, the Mayor and Council requested that the other Charter Officials' agreements reflect the same benefits as the City Manager; and

WHEREAS, the City is willing to offer the City Attorney amendments to his contract, pursuant to the terms and conditions of this Resolution.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The above recitals are confirmed, adopted, and incorporated herein and made part hereof by this reference.

Section 2. Approval. The Amended Employment Agreement by and between the City and Mr. Luis Figueredo, attached hereto as Exhibit "A", which is incorporated here in and made a part hereof by reference, is approved.

Section 3. Authorization. The Mayor is hereby authorized to execute the Amended Employment Agreement with Mr. Figueredo on behalf of the City, binding the City to its terms.

Section 4. Implementation. The Mayor and City Manager are hereby authorized to take such actions as may be necessary to implement the provisions of the Resolution.

Section 5. Effective Date. This Resolution shall become effective immediately upon its adoption.

The foregoing Resolution was offered by Vice Mayor Mariaca who moved its adoption. The motion was seconded by Councilmember Cabral and upon being put to a vote, the vote was as follows:


