WHEREAS, the City of Doral (the "City") issued an Invitation to Bid #2016-17 for "Office Furniture" (the "ITB") for Police and Public Works Expansion Project (the "Project") and received no submittals by the July 6, 2016 deadline; and

WHEREAS, the City had previously contracted with Pradere Office Products, the original provider of furniture for the City's Government Center and an authorized dealer of Affordable Interior Systems ("AIS Furniture"), via State of Florida Contract No. 420-420-10-1, for the purchase of office furniture for the Parks and Recreation Department; and

WHEREAS, recognizing the foregoing, the City's Procurement Division sought a price quote from Pradere Office Products for the provision office furniture for the Project; which was subsequently rejected by the City Council; and

WHEREAS, the Procurement Division then asked seven (7) vendors participating in State of Florida Contract No. 425-001-12-1 to provide quotes for the Project based on the same specifications for AIS Furniture provided in the ITB; and

WHEREAS, only one vendor, Office Bargain Center, provided a responsive quote, which was significantly lower than Pradere Office Furniture in the amount of \$64,988.48, which is attached hereto as Exhibit "A" (the "Quote"); and

WHEREAS, section 2-322 of the City Code of Ordinances authorizes the City to enter into bids or contracts entered into by other governmental authorities provided that the governmental authority has followed a competitive bidding procedure leading to the award of the bid or contract in question which is substantially similar to the competitive bidding procedure outlined in the City Code; and

WHEREAS, State of Florida Contract No. 425-001-12-1, administered by the State of Florida Department of Management Services, was competitively solicited following procurement procedures similar to those in the City Code; and

WHEREAS, in light of the lack of response to the ITB, the integrity of the timeline for the completion of the Project, and the significant savings found in the Quote, staff has recommended the City Council approve the purchase of office furniture from Office Bargain Center in the amount of \$113,500.00 and authorize the manager to execute an agreement to expend budgeted funds from Account# 001.60005.500640.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL
OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

incorporated herein and made a part hereof by this reference, is hereby approved. The foregoing approval, absent the mutual execution of an agreement between the City and Office Bargain Center, does not vest any contractual rights on Office Bargain Center.

<u>Section 3.</u> <u>Authorization to Procure Services.</u> The City Manager is hereby authorized to negotiate and enter into an agreement with Office Bargain Center, subject to approval by the City Attorney, as to form and legal sufficiency, for the provision of office furniture for the Project, and to expend budgeted funds in furtherance hereof from Account# 001.60005.500640.

Section 4. Implementation. The City Manager and the City Attorney are hereby authorized to take such action as may be necessary to implement the provisions of this Resolution.

<u>Section 5.</u> <u>Effective Date.</u> This resolution shall take effect immediately upon adoption.
