Dear Mr. Figueredo:

Pursuant to your request, The Goldstein Environmental Law Firm, P.A. (the "Firm"), is pleased to provide the City of Doral ("Client") with this engagement letter to prepare an administrative petition under § 120.57, Florida Statues, to appeal a pending permit modification for the Medley Landfill that allows for a vertical expansion from 265 feet NGVD to 340 feet NGVD (the "Expansion Permit"). The permittee is Waste Management, Inc. of Florida ("WMIF"). This letter confirms our understanding of the scope of work that Client would like the "Firm to perform on its behalf as well as the terms of our engagement. I. Scope of Work

- Procure and manage one or more environmental consultants experienced with landfill design, permitting, construction, and operations, groundwater chemistry, air emissions, and toxicology.
- Draft and file an administrative petition under § 120.57, Florida Statues, to appeal the Expansion Permit.
- Assist Client in Expansion Permit settlement negotiations with WMIF.
- Prepare briefing materials for the City Attorney to be utilized in connection with (i) confidential communications with City management and elected officials and (ii) risk communication and public outreach for Doral residents, homeowner associations, and business stakeholders.
- Any other matters related to the Expansion Permit requested by Client and confirmed in writing.

II. Fees and Costs

This engagement is being billed an hourly basis pursuant to the following schedule:

Notwithstanding the foregoing, Client will <u>not</u> be charged for any routine copying performed at the Firm's offices, the placement of any long-distance phone calls by the Firm, or any Firm transmittals via U.S. Mail or by facsimile.

Based on the Firm's existing relationship with Client, no retainer is required to begin work under this engagement. Services are invoiced monthly. Each invoice will contain detailed narratives to document services rendered and costs incurred. month. The Firm reserves the right to suspend or terminate its performance under this engagement letter or any other Client related matter if any payment remains outstanding for more than 30 calendar days.
