AN ORDINANCE OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AUTHORIZING THE ISSUANCE FROM TIME TO TIME OF THE CITY'S GENERAL OBLIGATION BONDS, IN AN AGGREGATE PRINCIPAL AMOUNT NOT EXCEEDING \$150,000,000, IN ONE OR MORE SERIES, FOR THE PURPOSE OF FINANCING THE COST OF BUILDING/ IMPROVING PARKS AND RECREATIONAL FACILITIES WITH SAFETY FEATURES, INCLUDING, BUT NOT LIMITED TO, GREEN SPACES, COMMUNITY CENTERS, CULTURAL AMENITIES, AQUATIC FACILITY, PLAYGROUNDS, SPORTS FIELDS AND FIVE MILES OF WALKING/ CYCLING TRAILS; PROVIDING THAT SUCH BONDS SHALL BE SECURED BY THE FULL FAITH AND CREDIT OF THE CITY OF DORAL AND PAYABLE FROM AD VALOREM TAXES LEVIED BY THE CITY WITHOUT LIMIT AS TO RATE OR AMOUNT ON ALL TAXABLE PROPERTY WITHIN THE CITY; PROVIDING THAT THE TERMS AND CONDITIONS OF SUCH GENERAL OBLIGATION BONDS AND ALL OTHER CONDITIONS FOR THE SALE AND ISSUANCE THEREOF SHALL BE SET FORTH OR PROVIDED FOR IN ONE OR MORE BOND RESOLUTIONS TO BE ADOPTED BY THE CITY COUNCIL PRIOR TO THE ISSUANCE OF EACH SERIES OF SUCH GENERAL OBLIGATION BONDS; PROVIDING FOR CONTINUING DISCLOSURE; PROVIDING FOR SEVERABILITY; PROVIDING FOR REPEAL OF INCONSISTENT INSTRUMENTS; AND PROVIDING FOR AN EFFECTIVE DATE
